# 1.0 INTRODUCTION

- 1.1 Attached to this report is the Audit Commission's joint audit and inspection 'Annual Letter' for Members. This replaces the Annual Audit Letter and it summarises the conclusions and significant issues arising from the Commission's audit and inspection programme during 2004 and it also comments on other current issues.
- 1.2 Members' attention is particularly drawn to the key messages contained in the Letter and shown on page 1,

"Bury Metropolitan Borough Council has improved to become a GOOD council. It has made significant improvements to housing, adult social services, libraries and leisure and environmental services over the last year".

"The improvement plan both demonstrates Bury's increased corporate ability and effectiveness with aims to further develop it".

Note the action needed shown on page 2, to the CPA and scorecard on page 3:

On achievement:

"Overall, the council's service performance has continued to improve during the year and now compares favourably with some excellent councils".

- 1.3 Overall, it is pleasing to note the fact that the Commission has given an unqualified opinion of the Authority's Accounts for 2003/04. It is also important to note that Commission has not felt it necessary to issue any statutory recommendations.
- 1.4 Audit Fee as a result of Bury being categorised as 'good' under the comprehensive performance assessment, the Audit fee for 2005-2006 will be reduced by £40,000.
- 1.5 The Letter is in draft form and Members will be able to make comments to the Commission at the meetings.
