SUMMARY:	This new Procurement Strategy for 2013-2015 sets out the Council's vision for procurement over the next three years, describing how the Council will procure goods, services and works by the most efficient and sustainable means to ensure that the needs and aspirations of the community are furthered, within a clear framework of accountability and responsibility. It recognises the challenges of the current economic climate and seeks to promote opportunities to further local economic benefit through procurement. It builds on the previous strategy's best practice principles, tools and techniques and articulates our strategic expectations from procurement activity.

1.0 BACKGROUND

- 1.1 This latest iteration of the Procurement Strategy builds on the outcomes of previous versions, recognising the progress made in relation to processes and structures (our procurement framework) which have been achieved by embracing technological solutions in order to maximise efficiencies (through our e-procurement tools for ordering P2P, sourcing -The Chest and spend analysis SpendPro), improve skills and collaboration internally (through training and the work of the Operational Procurement Network) and reduce risk by ensuring compliance with Contracts Procedure Rules and public procurement legislation.
- 1.2 The strategy will cover the three year period from January 2013 to December 2015.
- 1.3 All risks associated with the delivery of the Procurement Strategy will be detailed and addressed within the associated Action Plan, progress against which will be monitored by the Strategic Procurement Board.
- 1.4 An Equality Analysis has been completed. No adverse impacts were identified. Positive impact should result from more consistent application of the procurement

equality framework and consideration of social and wider community benefit during the procurement process.
