SUMMARY:	This report seeks approval to adopt a revised and updated Environmental Services Enforcement Policy with immediate effect which covers the enforcement and regulation carried out under the remit of Bury Council's Environmental Health, Licensing and Trading Standards services and replaces earlier enforcement policies. Approval is also sought to delegate authority to the Executive Director of EDS after consultation with the Executive Member for Neighbourhoods and Regeneration and Assistant Director - Legal and Democratic Services to make amendments to the policy if there are legislative or national guidance changes.

Corporate Aims/Policy Framework:	Do the proposals accord with the Policy Framework? Yes		
Statement by the S151 Officer: Financial Implications and Risk Considerations:	The purpose of the policy is to ensure compliance with the law and with regulations. Whilst there may be some income from the issue of penalties it is difficult to estimate the total receivable. It is not planned to introduce additional budget targets following the introduction of the policy.		
	The cost of any enforcement, preventative or remedial action will be met from existing budgets, primarily those for the staff involved in the activities. Resources in kind will also be available from the partner organisations that work with the Council on enforcing the policy. Legal costs may be incurred for cases taken to prosecution, though these may be recoverable from the defendant.		
	The risks are identified in para 2.5 of the report; the main concern is that having an outdated policy could result in legal challenges to the Council's enforcement and regulatory regimes. Adoption of the policy will mitigate this risk		
Statement by Executive Director of Resources:	Introduction of the policy and coordinated work with partner agencies will reduce the Council's exposure to risk and aims to make the most effective use of limited resources. To protect its finances the Council will seek to recover the full cost of remedial works & legal costs from those responsible for breaching regulations.

	The Council is responsible for enforcing a wide range of legal obligations many of which carry criminal sanctions for non compliance. Enforcement should be seen as part of the "toolbox" to fulfil any statutory duties and to achieve the Council's strategic priorities and outcomes. It should also be proportionate and risk based. To this end, the Enforcement Policy sets out general principles the Council would follow in relation to regulation of environmental issues falling within the remit of Environmental Services.

1.0 BACKGROUND

1.1 Fair and effective regulation and enforcement is essential to protect the health and safety of the public, the economic interests of businesses and the environment in the Bury Council area. It is recognised that decisions about enforcement action, and in particular the decision to prosecute, can have serious implications for all involved. The Environmental Services enforcement policy seeks to ensure that enforcement action is fair, proportionate and consistent and that everyone understands the principles which are applied when enforcement action is considered.

2.0 ISSUES

- 2.1 The updated Environmental Services Enforcement Policy will contribute to many of the Council's Corporate objectives including making Bury a better place to live, putting residents needs first and operating in an open and transparent way. It will also help promote greater individual, personal and corporate responsibility in the Borough.
- 2.2 The existing Environmental Services Enforcement policy is several years old and requires updating to take account of new guidance, the increasing availability of disposal by way of fixed penalty and best practice identified by Bury Council's enforcement officers and legal officers.
- 2.3 The policy will be published on the Council's website so that residents, businesses and those who visit the Bury Council area will know what to expect from the Council's Environmental Health, Trading Standards and Licensing services in an open and transparent way.

3.0 REVIEW

3.1 The policy will be reviewed every 2 years unless circumstances such as changes in legislation or Government guidance require it to be carried out at an

earlier date. Review may also take place through audit of those service areas accredited to ISO 9001 : 2008.

3.2 It is proposed that amendments to the policy resulting from changes in legislation or guidance can be made in consultation with the relevant Cabinet Member, Director of Environment and Development Services and Assistant Director – Legal and Democratic Services

4.0 RISK MANAGEMENT

4.1 The risks to the Council from not having an updated policy are:

Legal challenge on decisions to take enforcement action if there is no enforcement policy in place; or if there are omissions in an old policy. This may weaken local regulation and may result in a deterioration of environmental standards or business compliance and may pose a risk to the public's health and safety.

Financial penalty to the Council in the form of costs or damages awarded where cases are challenged in Court for not following current guidelines and policy

Undermining of local environmental improvement campaigns. The new policy clarifies the position with regard to issuing fixed penalty notices in the first instance without the need for prior warning or an opportunity to make amends. This will assist the Council to follow up cases of non payment with prosecution.

Reputational damage if the Council does not act in a consistent, transparent, fair and equitable manner as defined in the updated Environmental Services Enforcement policy

5.0 EQUALITY AND DIVERSITY

- 5.1 An Equality Analysis was carried out during the development of the enforcement policy and this concluded that the effect of the policy on equality was neutral and that there would be no impact on cohesion. Therefore we propose to proceed with the updated Environmental Services Enforcement policy subject to Cabinet approval
