1.0 BACKGROUND

- 1.1 The Child Poverty Act 2010 requires local authorities to produce child poverty strategies and to work with local partners to reduce and prevent child poverty in the area. In Bury, we feel that in order to achieve this we must look at poverty across all of our communities.
- 1.2 There have been two independent national reviews that have recommended focussing on early intervention and partnership working.
- 1.3 The National Child Poverty Strategy (2011) was published and aims to eradicate child poverty by 2020.

2.0 ISSUES

2.1 The Poverty Strategy sets a strong vision and strategic objectives to tackle poverty in Bury.

The main features of the strategy are:

- Details of the background of the strategy, needs assessment and consultation process.
- Details of projects that have been provided by Team Bury partnership organisations to be monitored for progress.
- Robust targets in place to enable progress to be measured and to maintain the focus on the outcomes that affect Bury's residents. The baselines and targets will be available following the completion of the year-end performance report in June 2013.

3.0 CONCLUSION

3.1 This strategy sets out to improve the way Team Bury partnership organisations can work together to reduce poverty and improve outcomes for the community whilst recognising the challenges presented by limited resources and the potential impact on capacity.
