#### 1.0 BACKGROUND

- 1.1 The Head of Transport has undertaken a detailed review of the fleet, taking into account the lease expiry dates, the age and condition of the vehicles and items of plant, consulting with users as appropriate on their future requirements under the Plan for Change.
- 1.2 Details of the proposed replacements for 2013/14 and 2014/15 are set out in Appendix A. Tenders will be sought in accordance with Financial and Contract Procedure Rules and European legislation for the purchase of the vehicles and plant. The specifications will include the requirement to conform to the latest environmental regulations.
- 1.3 Several vehicles and items of plant which are due for replacement based on their life expectancy are to be kept for at least a further 12 months as their condition does not warrant replacement. Any savings net of maintenance costs will be reflected in the revenue outturn for 2013/14.
- 1.4 The fleet now currently operates its vehicles using a 5% bio diesel blend. Fuel companies have been given a Government target to increase the bio diesel content from 5% up to at least a possible 30% in future years.
- 1.5 The Head of Transport will continue to include in the vehicle specification a request to the tenderers to provide prices for alternative fuelled vehicles and also to provide emission levels of all vehicles tendered for.
- 1.6 Wherever possible the Authority will, in line with current policy and practice, seek to obtain best value in the procurement of its vehicle requirements through collaboration with other AGMA Authorities, a review on Vehicle Procurement, Management and Maintenance has now been completed. We will also examine the options available through framework and single source agreements let by other Consortia and Government Bodies.

### 3.0 AMENDMENTS TO 2012/13 PROGRAMME

- 3.1 The following are to be mostly deferred to 2013/14. Where vehicles are deferred due to later procurement existing vehicles have been retained during the procurement process. Full details of the vehicles deferred are shown in Appendix B
- 3.1.1 Item 3.1.1 of 2012/13 report, 1 Minibus has now been revenue purchased and its operational condition will be reviewed during 2013/14 and await decision from St Monica's High School for approval to replace.
- 3.1.2 Item 3.1.3 of 2012/13 report, replacement of one Land Rover will be further deferred to 2013/14, subject to service review.
- 3.1.3 Item 3.1.5 of 2012/13 report, the replacement of 5 Small accessible buses will again be deferred to 2013/14, pending discussion with Adult Care on their future service requirements.

- 3.1.4 Item 3.1.6 of 2012/13 report, 1 Fork Lift truck deferred to 2011/12, subject to its condition. This will be reviewed during 2013/14 in line with service requirements.
- 3.1.5 Item 3.1.12 of 2012/13 report, 1 Car Derived Van deferred to 2013/14 in line with service requirements.
- 3.1.6 Item 3.1.13 of 2012/13 report included 9 Light Vans; 3 of these have been re-hired to Adult Services, 1 has been re-hired to Building Cleaning for 6 months, 2 are to be retained and used as cover vehicles, and 3 are to be disposed of, reducing the fleet.
- 3.1.7 Item 3.1.14 of 2012/13 report, 1 Pick-up deferred now to 2013/14.
- 3.1.8 Item 3.1.16 of 2012/13 report, 6 Trailers have now been deferred to 2013/14
- 3.1.9 Item 3.1.17 of 2012/13 report, 4 Site Cabins have now been deferred to 2013/14
- 3.1.10 Item 3.1.18 of 2012/13 report, 1 Mobile Site Cabin has now deferred to 2013/14
- 3.1.11 Item 3.1.19 of 2012/13 report, 1 Roller and Trailer has now deferred to 2013/14
- 3.1.12 Item 4.1.1 of the 2012/13 report, 5 Large Welfare buses, lease extended by 12 months to Oct 2013, to be reviewed in line with Adult Care service requirements.
- 3.1.13 Item 4.1.2 of the 2012/13 report, 1 Light Van, lease extended by 24 months to July 2014 and replacement now planned for 2014/15.
- 3.1.14 Item 4.1.3 of the 2012/13 report, 28 Medium Vans, leases extended by 24 months to July 2014 (10 vans) and Oct 2014 (18 vans); replacement now planned for 2014/15
- 3.1.15 Item 4.1.4 of the 2012/13 report, 2 Refrigerated Vans, lease extended by 24 months to Oct 2014 and replacement now planned for 2014/15
- 3.1.16 Item 4.1.5 of the 2012/13 report, 14 Small Tippers, lease extended by 24 months to July 2014 and replacement now planned for 2014/15
- 3.1.17 Item 4.1.6 of the 2012/13 report, 7 Medium Tippers, only 5 purchased to meet Highway's service requirements. Fleet reduced by 2 tippers.
- 3.1.18 Item 4.1.7 of the 2012/13 report, 1 Trackaire, lease extended by 24 months to July 2014 and replacement now planned for 2014/15
- 3.1.19 Item 4.1.8 of the 2012/13 report, 2 Loading Shovels deferred to 2013/14. A review of service requirements will be undertaken with the likelihood of a reduction of one vehicle. The remaining vehicle to be replaced in 2013/14 or its lease extended.
- 3.1.20 Item 5.1.2 of the 2012/13 report, 2 Double Drum Rollers, revenue purchased retained for further 12 months
- 3.1.21 Item 5.1.3 of the 2012/13 report, 5 Single Drum Rollers/Trailers, lease extended by 12 months to Jan 2014

- 3.1.22 Item 5.1.4 of the 2012/13 report, 1 Mobile Compressor, deferred to 2013/14 subject to review of its condition.
- 3.2 The following are **reductions** from the 2012/13 programme:
- 3.2.1 Item 4.1.9 of the 2012/13 report, 4 RCV's disposed of and not replaced.
- 3.3 The following is an addition from the 2012/13 programme:
- 3.3.1 An additional requirement of a 3.5 tonne Caged tipper to meet service requirements for Six Town Housing.

### 4.0 VEHICLE REPLACEMENTS 2013/14

- 4.1 The Head of Transport has assessed the likely replacement requirements for 2013/14 and the indicative requirements are included in this report for approval in order that the procurement process can be started as soon as possible. Due to on going Plan for Change reviews, the requirement of all V&P items will be re-assessed and confirmed with users prior to orders being raised. A review of requirements for 2013/14 will be ongoing and any proposed amendments will be notified accordingly. A detailed list of vehicles to be replaced is shown at Appendix C
- 4.1.1 <u>13 x Large Welfare Buses</u> 5 deferred from 2012/13 and 8 with leases expiring during 2013/14 4 in October 2013 and 4 in February 2014

  Replacement of the welfare buses will only take place following discussion with Adult Care on their future service requirements.
- 4.1.2 1 x Small Welfare Bus deferred from 2012/13
- 4.1.3 8 x Accessible Buses 4 deferred from 2012/13 and 4 with leases expiring during 2013/14 2 in February 2014 and 2 in March 2014:
- 4.1.4  $\underline{1}$  x Minibus deferred from 2012/13, awaiting decision from school on its replacement
- 4.1.5 1 x Car Derived Van deferred from 2012/13, awaiting service review outcome
- 4.1.6 <u>11 x Light Vans</u> with leases expiring during 2013/14 9 in November 2013 and 2 in March 2014:
- 4.1.7 <u>11 x Medium Vans</u> with leases expiring during 2013/14 9 in November 2013 and 2 in March 2014:
- 4.1.8 <u>1 x Pick-up</u> deferred from 2012/13, awaiting service review outcome
- 4.1.9 1 x Dropside with Tail lift with lease expiring in August 2013
- 4.1.10 3 x Small Tippers with leases expiring in November 2013
- 4.1.11 3 x Medium Tippers with leases expiring in October 2013
- 4.1.12 2 x Medium Tippers with Crane with leases expiring in February 2014
- 4.1.13 1 x Fork Lift Telehandler deferred from 2012/13, awaiting service review

- 4.1.14 <u>2 x Loading Shovels</u>, subject to operational review. One of the loading shovels is owned outright, the lease on the other has been extended to Oct 2013.
- 4.1.15 <u>1 x Precinct Sweeper</u> with lease expiring in January 2014
- 4.1.16 1 x Hooklift Skip Loader with lease expiring in February 2014
- 4.1.17 5<u>x Access Platform Vehicles</u> with leases expiring in February 2014. Replacement will be subject to new maintenance regimes following the introduction of LED street lighting
- 4.1.18 1 x Land Rover deferred from 2012/13

### 4.2 Additional Requirements

- 1 x Small Caged Tipper with Tail lift to meet service requirements of Six Town Housing
- 1 x Dog Warden Van to meet service requirements of Environmental Services

### 5.0 PLANT REPLACEMENTS 2013/14

- 5.1. <u>2 x Double Drum Roller</u> deferred from 2012/13 to be reviewed in line with service requirements
- 5.2 <u>6 x Single Drum Roller & Trailer</u> deferred from 2012/13 to be reviewed in line with service requirements
- 5.3 <u>19 x Trailers</u> 6 of which have been deferred from 2012/13. Annual condition reviews will be undertaken before trailers are replaced
- 5.4 <u>1 x Mobile Site Cabins</u> deferred from 2012/13, subject to annual condition review
- 5.5 4<u>x Site Cabins</u> deferred from 2012/13, subject to annual condition review and operational requirements
- 5.6 1 x Mobile Compressor deferred from 2012/13, subject to annual condition review and operational requirements.

A full list of plant items to be replaced is shown at Appendix C

#### 6.0 VEHICLE REPLACEMENTS 2014/15

- 6.1 The Head of Transport has also assessed the likely replacement requirements for 2014/15 and the indicative requirements are included in this report for approval in order that the procurement process can be started as soon as possible. A review of requirements for 2014/15 will be ongoing and any proposed amendments will be notified accordingly. The detailed list of planned replacements is shown in Appendix D
- 6.1.1 3<u>x Small Welfare Buses</u> with leases expiring in August 2014, subject to Adult Care Services requirements
- 6.1.2 1 x Accessible Bus with lease expiring in March 2015

- 6.1.3 <u>21 x Light Vans</u>, 1 of which has been deferred from 2012/13 by extending the lease to July 2014, and 20 with leases expiring in March 2015
- 6.1.4 37 x Medium Vans of which 28 have been deferred from 2012/13 by extending the leases (10 to July 2014 and 18 to Oct 2014). The other 9 have leases ending during 2014/15 (1 in Nov 2014, 1 in Jan 2015 and 7 in March 2015)
- 6.1.5 2<u>x Refrigerated Vans</u> deferred from 2012/13 by extending the lease to October 2014.
- 6.1.6 <u>16 x Small Tippers</u> of which 14 have been deferred from 2012/13 by extending the leases to July 2014 and 2 have leases ending during 2014/15 (1 in July 2014 and 1 in December 2014)
- 6.1.7 2 x Small Box Vans with leases expiring in January 2015
- 6.1.8 1 x Medium Tipper with lease expiring in July 2014
- 6.1.9 1 x Medium Tipper with Crane with lease expiring in July 2014
- 6.1.10 1 x Medium Tipper with Compressor with lease expiring in July 2014
- 6.1.11 <u>2 x Trackaire</u> 1 of which has been deferred from 2012/13 by extending the lease to July 2014, and 1 with lease expiring in December 2014

#### 7.0 PLANT REPLACEMENTS 2014/15

7.1 <u>2 x Trailers</u> which are owned outright, subject to annual condition review and operational requirements.

### 8.0 RESOURCES 2013/14

- 8.1 The Vehicle and Plant Replacement Programme approved by the Cabinet on 07/03/12 provided for expenditure of £4,828,900 in 2012/13.
- 8.2 Expenditure of £824,800 originally planned for 2012/13 will slip to 2013/14. The total expenditure in 2013/14, including the £842,800 brought forward, will be £2,593,000.

8.3 It is proposed to fund the replacements in 2013/14 as follows:

Before leasing arrangements are made the Executive Director of Resources compares the cost of the lease with the alternative of prudential borrowing; if borrowing is deemed to be more cost effective then the vehicles will be funded by loan instead, with the funding costs being charged against revenue instead of leasing costs.

- 8.4 The revenue implications arising from vehicle and plant replacements are included in the Authority's Revenue Budget 2013/14. Should surplus monies become available during the year from within Transport Operational Account from, for example, disposal of vehicles or vehicle funding transactions then consideration will be given to increasing the level of revenue funding for the replacements. By extending the lease on selected vehicles it has been estimated this will reduce annual leasing payments by £28,569, however this will be off set by an increase in vehicle servicing and maintenance cost.
- Work continues to be undertaken at AGMA level to introduce more effective 8.5 collaboration on the purchase of vehicles. Where possible we will collaborate with other AGMA Authorities and/or utilise existing agreements let by the Yorkshire Purchasing organisation (YPO) or use the existing Fleet Framework agreement established by Oldham Council. Any procurements undertaken via YPO or the fleet framework agreement will be carried out as a mini competition in accordance with the procedure for frameworks under the EU Procurement Directives and implemented in English Law in the Public Contracts Regulations 2006 (SI 2006 No.5). Qualified framework contractors will be invited to submit pricing and respond to a quality assessment questionnaire which will be evaluated in accordance with the pre-agreed and published criteria by a panel made up of both of Procurement and Transport Where it is not viable to use an existing arrangement a new Procurement process will be carried out in line with the Council's contract procedure rules. All contract opportunities and mini competitions will be conducted utilizing the Council's e-tendering portal, The Chest.

#### 9.0 CONCLUSION

9.1 The proposed replacement programme is necessary to ensure continued operation of the Council's functions. Approval of the replacement programme will result in committed expenditure for the period of the lease arrangement (at least 4 years) so it is important that continued use of the items replaced is required over this time period. User departments will be responsible for the costs over this period and these will need to be met from their revenue budgets, unless alternative uses can be found for the vehicle. The ongoing cost commitments need to be taken into account when proposing future years' savings.
