2.0 SUMMARY

This report contains proposals for the dates of meetings for the 2003/2004 Municipal Year.

3.0 OPTIONS AND RECOMMENDED OPTION (with reasons)

Option 1

- Increase the number of meetings cycles to 5 per year (5 x 7 or 8 week cycles).
- Executive to meet every 3 weeks.
- Area Boards to meet 1 x per cycle.
- Scrutiny Panels/Commissions to meet 1 x per cycle.
- No change to no. of meetings per cycle of Regulatory Committees.

- Option 2**
- No change in the 4 meeting cycles per year (4 x 10 week cycles).
 - Executive to meet every 3 weeks.
 - Scrutiny Panels/Commissions to continue to meet 2 x per cycle where required.
 - Area Boards to meet 5 x per year.
 - No change to no. of meetings per cycle of Regulatory Committees.

- Option 3 (Current)**
- No change in the 4 meetings cycles per year (4 x 10 week cycles).
 - Executive to continue to meet every 2 weeks.
 - Scrutiny Panels/Commissions to continue to meet 2 x per cycle where required.
 - Area Boards to continue to meet 2 x per cycle.
 - No change to no. of meetings per cycle of Regulatory Committees.

Recommended Option:

To approve a timetable of meetings for the Council, the Executive, Scrutiny Panels/ Commissions, Regulatory Committees, Area Boards and other bodies for the 2003/2004 Municipal Year based on Option 2.

5.0 INTRODUCTION

Initial guidance is required to enable the timetable of meetings for 2003/2004 to be prepared.

6.0 CURRENT TIMETABLE

6.1 The current timetable is based on the following general principles:-

- (i) 4 x ten week cycles of meetings per year
- (ii) No meetings during the summer recess and the Christmas/New Year Period
- (iii) Avoidance where possible, of meetings on religious holidays and for periods of party conferences
- (iv) Avoidance, if at all possible, of the doubling up of meetings on the same evening

6.2 The current timetable reflects the following guidelines:-

- (a) Council to meet on a Wednesday at the end of each cycle. Plus Annual Council and Budget Council.
- (b) Executive to meet on a Wednesday every 2 weeks
- (c) Scrutiny Commissions/Panels (5) to meet 1 to 2 x per cycle as follows:-
 - Healthier and Safer Communities – 2 x per cycle
 - Economy, Environment and Transport – 2 x per cycle
 - Learning Communities – 2 x per cycle
 - Performance Management – 1 x per cycle
 - Resource – 2 x per cycle

- (d) Area Boards (6) to meet 2 x per cycle and not to meet in school half terms
- (e) Standards Committee and Audit Sub-Committee to meet 1 x per cycle
- (f) Planning Control Committee to meet 1 x per month
- (g) Labour Group to meet on the Monday prior to the Executive and Council meetings.
- (h) Scrutiny Management Committee and Area Board Chairs Group to meet 1 x per cycle.
- (i) Youth Cabinet to meet 1 x per cycle
- (j) JCC Teachers/JCC Lifelong Learning and JCC Corporate each to meet 1 x per cycle

7.0 NUMBER OF MEETINGS

7.1 One of the main objectives of the modernising agenda was to reduce the number of meetings attended by elected Members in order to give them more time to undertake their representational role.

7.2 However, the implementation of the new structures under the modernisation agenda has not led to a reduction in the number of meetings attended by elected members. Whilst the number of 'Committees' has decreased, the number of meetings of those bodies in accordance with the above general principles and guidelines has increased as indicated below:-

7.3 There has been a 24% increase in the number of meetings resulting largely from the doubling of Scrutiny Commissions/Panels and Area Board meetings, together with the creation of Scrutiny Sub Groups.

7.4 It should also be noted that the number of Education Appeals Panel meetings, although not now involving elected Members but still supported by Democratic Services, have also increased as indicated below:-

8.0 **MEMBER ROLES**

8.1 Whilst the introduction of the new political management arrangements has concentrated actual decision-making with a small number of Executive Members, an Area Board Structure and a series of Scrutiny Commissions/Panels have been developed to act as a link with the citizens of the Borough and to keep a check on the decisions of the Executive.

8.2 In addition to the roles within the new political management structure Members undertake a significant representative role representing the Authority in its relationships with other bodies within their wards and with constituents.

8.3 Partnership arrangements with local stakeholders are actively promoted in order to both lead and engage the community. These include community safety, early years development, single regeneration budget activities as well as the Local Strategic Partnership.

8.4 Other representational roles of Members include:-

- Joint Authority viz
 - Greater Manchester Police Authority
 - Greater Manchester Fire and Civil Defence Authority
 - Greater Manchester Passenger Transport Authority
 - Greater Manchester Waste Disposal Authority
- 21 internal bodies linked to the decision-making structure but not formally part of it, such as Joint Consultative Committee with Teachers and Trade Unions, advisory groups and panels on housing and highways matters.
- Approximately 82 outside bodies ranging from major national and regional bodies to more local bodies and voluntary organisations.
- Boards of Governors of local primary and high schools.

8.5 The role of Members as ward representatives and community leaders is promoted through Area Boards, public meetings and members' political surgeries. All Members hold a ward representative role and carry this share of ward/constituent casebook.

9.0 **FUTURE CHANGES – LICENSING**

9.1 It is likely that the number of meetings of the Licensing and Safety Panel will increase dramatically during 2003/2004 due to the proposal for the transfer of the granting of licences for the sale and supply of alcohol from the Magistrates to Local Authorities contained in the Licensing Bill.

9.2 There will be major resourcing implications for Democratic Services in servicing these meetings, as well as the Licensing Unit and Legal Services. It will also lead to the need for a greater commitment in time for Members of the Panel in attendance at these meetings or a larger Panel from which sub-panels could be drawn. (Detailed provisions are not known at this stage)

10.0 **OPTIONS**

10.1 **Option 1**

10.1.1 Move to a timetable of meetings based on:-

- 5 x 7 or 8 week cycles of meetings per year viz

	Cycles	Council Meetings
1.	Mid May/June/July	Mid July
2.	September/October	End October
3.	November/December	End December (Prior to Xmas)
4.	January/February	End February + Budget Meeting
5.	March/April	End April + AGM Mid May

- Executive to meet every 3 weeks and not the current 2 weeks
- Scrutiny Panels/Commissions to meet 1 x cycle but with ad hoc Sub Group meetings as necessary
- Area Boards to meet 1 x per cycle
- JCC's to meet 4 times per year each
- No changes to other meetings or recesses

10.1.2 This would reduce the number of formal meetings from 182 to 141 per year which represents a reduction in the number of meetings of 29%. It in fact brings the number of meetings back to that under the streamlined 'traditional' structure of 1998/1999.

10.1.3 The main pressure for more meetings has in the recent past come from Scrutiny Panels/Commissions and Area Boards and, although this option will reduce the number of meetings from 8 to 5 per year, it is still an increase over the original pilot structure figure of 4 per year (1999/00).

10.2 Option 2

10.2.1 No change to the current general principles (i.e. retain quarterly cycle of Meetings etc) or guidelines, except Executive to meet every 3 weeks and to reduce the number of Area Board meetings to one per cycle.

10.2.2 This would however reduce the number of Area Board meetings by 50% and may lead to a proliferation of additional/special meetings. It is, therefore, proposed that 5 meetings each per year would help to prevent the need for additional meetings.

10.2.3 However the number of Scrutiny Panel/Commission Meetings would remain the same.

10.2.4 This would achieve the same objective of reducing the total number of meetings from 182 to 151.

10.3 Option 3

10.3.1 No change to the current general principles and guideline and continue with the current level of meetings. The number of meetings would rise in any event due to the extension of functions of the Human Resources and Appeals Panel and this is reflected by the figures in brackets in the table at 7.4 below.

10.4 Option Figures

The figures for the number of meetings under the 3 options are set out below:-

11.0 CONCLUSIONS

11.1 Clearly the objective of reducing the number of meetings attended by Members has not been achieved and therefore Members do not have more time to spend on their representational role.

11.2 The vast majority of meetings are held during the evening and, as the number of meetings has increased, it has been necessary to 'double up' some meetings on the same evening. Inevitably this has also led to an increasing number of clashes with meetings of outside bodies and Governing Bodies of Schools.

11.3 It is proposed that Option 2 be adopted in accordance with the following appendices which are appended to the report:-
