EX.170 n BEST VALUE PERFORMANCE PLAN 2003/2004

The Minutes of the meeting of the Performance Management Scrutiny Panel held on 3 June 2003 were submitted at the meeting.


Councillor Treadgold, Chair of the Scrutiny Panel, attended the meeting to report on the comments of the Panel.

n RECOMMENDATIONS TO COUNCIL:

- 1. That the draft Best Value Performance Plan 2003/2004 be approved incorporating the following comments of the Scrutiny Panel:-
 - (i) Improvements referred to in the Plan should be quantified to demonstrate the scale of improvement being achieved.
 - (ii) Inclusion of the date by when the Post-Ofsted Action Plan will be submitted to the Department for Education and Skills.
 - (iii) That the Social Services Department be consulted on whether the results of the recent Fostering and Adoption Report can be included in the Plan; and
 - (iv) Examples of improvements and good practice in the Townships outside of Bury Town Centre, be incorporated.
- 2. That Housing Services be asked to consider the Panel's recommendation that a programme of dropped pavement crossings be implemented on the Council housing estates.
- 3. That the Chief Executive, in consultation with the Executive Member Performance Management, be authorised to approve any final amendments prior to publication.
