C.835 THE LEADERS' COMMEMORATIVE PLAQUE – UNVEILING CEREMONY

C.838 MAYORAL COMMUNICATIONS AND ANNOUNCEMENTS

The Worshipful the Mayor wished all Councillors, Officers and residents of the Borough a Happy Christmas with every good wish for the New Year 2006.

C.839 PUBLIC QUESTION TIME

- a) The following issues were raised in relation to the ongoing strategic review of secondary educational provision by members of the public to which responses were given by Councillor Gibb.
 - The effects on local County high schools of increases in the intake-limits of high schools in the Voluntary Aided Sector. (Written response promised.)
 - Representation of the Voluntary Aided Sector with voting rights on the School Organisation Committee which will consider the final proposals. (Written response promised.)
 - Several of the affected schools are currently oversubscribed.
 - An allegation that the forecasts of future pupil numbers were inaccurate.
 - The use of land at Philips High School.
 - The time lost to the consultation period by the Christmas/New Year holiday.
 - Possible disruption to the education of pupils particularly those completing their GCSEs in 2007.
 - The responses to the review by the Governors' Forum and Secondary School Headteachers.

- The effect of the consultations which will create rivalries between affected schools.
- Involvement of affected pupils in the consultation through School Councils.
- Forecasts of new house building in the Borough which would affect the demand for school places.
- Sales of land surplus to educational needs. The Leader gave a commitment that proceeds from sales of educational land would be retained within the Education Service.
- Several requests for an extension of the consultation period were submitted from members of the public. Councillor Gibb responded by stating that the need for further time for consultations could only be assessed at the expiry of the specified Phase 2 deadline of 6 January 2006.
- A request for representations to be made to the Government to provide the necessary funding to enable all of the affected high schools to continue to operate at their current levels.

In response, Councillor Gibb reported on the extensive lobbying of the Government for additional funding for the Education Service and reiterated that with falling secondary pupil numbers in the future, the secondary schools would become unsustainable. Councillor Gibb was concerned that the high educational standards within the Authority were maintained.

Several Councillors and members of the public expressed the view that educational staff morale must be maintained for the benefit of pupils' educational attainments.

The Mayor, in thanking those members of the public who had spoken for their contribution, accepted a petition containing approximately 2,000 signatures in opposition to the proposals set out in the Consultation Paper.

C.840 RECOMMENDATION OF THE EXECUTIVE

Minute EX.817 of the Executive held on 30 November 2005 - Children's Services – Fairfield Hospital

- 3) Demands Local MP's and MEP's confirm their unqualified support for the continued operation of all services of Fairfield Hospital in Bury and the retention of all its critical facilities.
- 4) Actively encourage residents and friends of Bury Fairfield Hospital to take up the invitation of the 'Bury Times' to express their views on these proposals with a view to mounting a Public Campaign to preserve these vital and life saving services for patients from Bury and its surrounding area".
