1.0 BACKGROUND (brief)

The legal process requires that the Council announces that a review is to take place. The Council consults the Returning Officer who makes representations on existing and proposed arrangements. The Council publishes the Returning Officer's proposals and invites comments. These are considered before final decisions are made.

The consultation must actively seek comments from people who have particular expertise in relation to access to premises or facilities for persons who have different forms of disability.

Any elector may make representations. Although not specifically required in law, the consultations include local political parties and elected representatives.
