1. Over the past 5 years surveillance powers have been used by local authorities over 10,300 times including over 165 times by Bury Council.

- 2. The growing concern that in some instances these powers are being exercised too readily.
- 3. That Council Members have a duty to be aware of the powers being exercised by the authority and to satisfy themselves on behalf of the Council workforce and the public that they are being used wholly in accordance with the Government's published code of practice.

Furthermore it is noted that the use of these (RIPA) powers by Bury officers, and the procedures and checks employed have yet to be scrutinised by Councillors.

As such this Council resolves to:

- * Request that a detailed report into this Council's use of RIPA powers over the past 5 years be presented to the appropriate Scrutiny Commission before the end of the year.
- * Further request that the Councils' Procedural Guide for the use of covert surveillance and covert human intelligence sources ("CHIS") be scrutinised by the Scrutiny Commission."
