2. Approve the Township Forum's Terms of Reference as attached as Appendix A; and delegate power to the Assistant Director of Legal and Democratic Services to make any consequential amendments to the Constitution.

The Council may appoint area committees as it sees fit if it is satisfied that to do so will ensure improved service delivery in the context of best value and more efficient, transparent and accountable decision making.

1.0 BACKGROUND

- 1.1 The Council currently has no formally constituted area committees but has carried out its community leadership role in recent years through the former Team Bury Local Area Partnerships. It is now considered that the Council should change the arrangements regarding its direct engagement with communities to continue to actively promote and encourage diversity and give a voice to local residents.
- 1.2 By reintroducing Council area committees it is considered that there will be a refocus on the debate of local issues; holding Members to account where necessary and finding local solutions for the benefit and wellbeing of local communities.
- 1.3 Within the Terms of Reference there will still be a focus on forming partnerships with other local pubic, private voluntary and community sector organisations, to address local needs.
- 1.4 The Council has allocated £1,000 per ward to support the work of voluntary and community groups. It is proposed that application funding decisions would be made by the relevant ward councillors. Individual grants would be for a maximum of £250 and applicant organisations would need to be formally constituted.
- 1.5 Additionally, a borough-wide allocation of £13,000 is available for "cross-ward" applications from third sector organisations, with a maximum individual grant of £750. These applications would be determined by the Council's Small Grants Panel. Funding decisions for both these schemes would be reported to the relevant Township Forum(s) with a follow-up evaluation after 3-6 months.
- 1.6 The Terms of Reference are set out in a proposed new Article 10 (attached as Appendix A) for insertion into the Constitution, which will replace the current version. Consequential changes will also be necessary to the Constitution.

2.0 Recommendation

- 2.1 That the proposed arrangements for Township Forums as outlined in this report be approved and that the Council Constitution be amended accordingly.
- 2.2 That the detailed operating model and membership arrangements for the Forums are drafted following consultation with interested parties and are brought back to the Executive for approval in due course.
