"The Council notes with concern the recent decision of the Government to reduce our armed personnel resulting in a proposal to disband the 2nd Battalion of the Royal Regiment of Fusiliers.

- (iii) make available hard copy petitions for signature at all Council owned buildings;
- (iv) requiring the Leader to write to all Councils and MP's in the North West to seek their support."
