1.0 BACKGROUND

1.1 An extensive review of meeting arrangements was undertaken prior to the 2005/2006 Municipal Year. One of the original objectives of the new political management structures was to reduce the number of meetings Members attend in order to allow more time to concentrate on their community leadership and representational roles. This timetable accords with that objective.

2.0 ISSUES

- 2.1 Consultations on the operation of the current year's meeting arrangements have identified general satisfaction with no adverse comments received.
- 2.2 Specific regard in the 2013/2014 Timetable has been taken of:-
 - Principal religious holy days in the Christian, Jewish and Muslim Calendars
 - Political Party Conferences
 - School holidays
 - Local Government Association Conference
 - A summer Recess of three weeks in July/August
 - The meetings of the Member Development Group, Corporate Parenting Panel and Health and Wellbeing Board are now included in the Timetable

- The Elected Member Training Days are again included in the Timetable. No other meetings involving Members are to be organised on these days.
- The Employee Achievement Awards Ceremony is included in the Timetable.
- 2.3 It has been confirmed that the dates for the European Elections in 2014 are Thursday 22 May and Sunday 25 May. It is therefore likely that local elections in England will be held on Thursday 22nd May 2014. Should that be the case, the meeting of Annual Council scheduled for 14 May 2014 will be rearranged and an additional cycle of meetings drafted.
