1.0 Purpose of the Report

The report is to bring to the Health and Well Being Board the latest comments/feedback from the CCG Board and Health Scrutiny meetings held recently.

The Board members are asked to consider whether to include these comments into the Strategy and amend it accordingly for approval.

2.0 Background

Included amongst the Board's main duties is to develop a Joint Health and Well Being Strategy, informed by the JSNA and local views and ensure it is reflected in commissioning plans.

The Board, whilst in its shadow format, established two Task and Finish groups to manage the process of bringing the Strategy to fruition. A comprehensive consultation process has been undertaken since July 2012.

The final stages involved seeking comments and feedback from the CCG Board and Health Scrutiny.

3.0 Issues

3.1 CCG Board

Suggested additions from the CCG Board:

Priority 2:

Review and develop obesity interventions and services in Bury to ensure they meet the needs of children, families, and adults.

Priority 5:

To better identify those with dementia through awareness raising around the early symptoms of dementia and encouraging people to seek help early. Ensure GPs have access to training and tools to spot the early signs of dementia and increase the level of recorded diagnoses of dementia.

3.2 <u>Health Scrutiny</u>

Key issues raised by Members of the Health Scrutiny included:

- Needing clarity on measures and performance in order for the committee to scrutinise effectively, yet understanding many of the key actions are long term aspirations.
- More clarity on how the "Hub" would work, particularly on how that would be reflected in terms of delivering the Township Plans in the future.
- What measures will be taken to ensure effective ongoing communications and engagement during the life of the Strategy? Can the Next Steps section be enhanced to reflect and reassure on this?

4.0 Conclusion

Board's views are sought on the comments received and how they could or should be reflected in the strategy. If the comments are accepted the Board is asked to approve the Strategy. It is also proposed that if the Strategy is approved that it be adopted by the Council as part of it's Policy Framework within the Constitution.
