5.0 **APPEAL DECISIONS**

5.1 **Stonehaven, Bolton Road, Hawkshaw (40053/03)**

Appeal allowed – convert private swimming pool to swimming school, with an extension.

The Inspector felt that it was a small scheme that would not generate problem traffic or parking. An hours restriction was imposed – 7.00pm finishing time in the week and 1.00pm on Saturday.

5.2 **29 Cromer Road, Brandlesholme (40710/03)**

Appeal dismissed – 2 storey front extension to a dormer bungalow

The Inspector felt that the roof of the extension did not match the style of the existing building, and would unbalance the appearance.

5.3 **St Anne's Parish Church, Chapel Street, Tootington**

Appeal allowed – restoration of former National School, demolition of Victorian Hall and erection of new church-related community facilities.

The Inspector felt that conservation and design were the main issues. He thought that demolishing the Victorian Hall would benefit the setting of the remaining buildings and that the design of the new building was high quality. He felt that the Council had failed to demonstrate the conservation value of the hall and that there were no reasonable arguments against the proposal on grounds of noise, disturbance, smells, overlooking, traffic generation or parking. The Inspector concluded that the Council had acted unreasonably and had put the applicant to unnecessary expense.

A bill for costs has now been submitted by the applicants and is just under £28,000. The Council's own costs for using consultants at the Public Inquiry were about £5,125.
