43931 Sports Pitches, Philips Park Road West, Whitefield – Pilkington Park Ward

Construction of single lane access track – retrospective application.

The proposed development would be seriously detrimental to the visual amenity of the locality and in particular the residential amenities currently enjoyed by the occupiers of the nearby dwelling houses, by reason of its size, position, design and appearance. The proposed development therefore conflicts with policy EN1/2 of the Bury Unitary Development Plan.
