# INTRODUCTION

This report presents Members with a description of the various Planning Enforcement Notices served and Actions taken during 2005/6 and makes some comparisons with the previous year.

All Enforcement Notices served and Actions taken are considered against the provisions of the Human Rights Act 1998. In taking account of whether to serve an Enforcement Notice or take Action, which is a discretionary power afforded to Councils under the Town and Country Planning Act, 1990 as amended, consideration is taken as to whether the individual's rights are affected and whether it is expedient to serve such a Notice or take Action against the individual.

#### CURRENT STAFFING LEVELS AND WORKING ARRANGEMENTS

The Enforcement Team is part of the Development Control Section and currently comprises of a Senior Planning Enforcement Officer (full time) and a Planning Enforcement Officer, who is employed working 4 days a week. Both Officers deal with complaint cases on a Borough – wide basis, in accordance with the Council's Customer Charter for the Planning Enforcement Service.

During 2005 there was some considerable disruption to the service due to the two previous post holders both leaving for employment elsewhere and for much of the year there was a single person in post.

## WORKLOAD/COMPLAINT CASES RECEIVED

Enforcement is primarily a reactive service and does not generally monitor development in a proactive manner. The number of complaints received is therefore the only indicator of the case loads involved.

In 2004/5 - 370 complaint cases were received.

In 2005/6 - 461 cases were received.

The service does not include issues relating to Tree preservation Orders but does include the issue of High Hedges. To date there have been no formal complaints received in respect of High hedges although there have been a number of enquiries.

Each and every complaint is acknowledged and investigated firstly to identify whether there is an issue that involves Planning. In the past 12 months 138 cases were proven to not be about planning issues but nonetheless needed to be investigated.


The majority of cases, involving planning issues, are resolved without recourse to formal Enforcement Action. These cases are subject to site visits, liaison with the complainant and negotiations with the individual about whom the complaint has been made. The time spent on each case is variable but often involves repeat visits and several rounds of negotiations. During the year there were 240 cases closed or resolved, however there was a significant increase in the number of Enforcement Notices served and other Actions taken during 2005/6, as indicated below.

# FORMAL NOTICES SERVED/ACTIONS TAKEN

Were formal action is necessary the case officers liaise with and instruct the Head of Legal Services who drafts the required legal documentation. This formal action is the start of a complex process in which the offender has rights of appeal and where action in the Magistrates Court may be required to resolve the matter.

A breakdown of the Notices served for during 2005/6 is shown below, indicating the location and breach of Planning Control, the type of Notice served and the result of serving the Notice. The number of Appeals made in the Period is also indicated.

# **CONCLUSIONS**

The number of planning Enforcement complaints is rising and this is symptomatic of the greater interest in planning issues generally. The level of formal action is also increasing.

The current staffing levels are adequate to handle the current level of complaints and Enforcement Activity but there is not at this moment in time adequate resources to expand the service and be more proactive in monitoring development activity.
