P.1 DECLARATIONS OF INTEREST

P.2 MINUTES

Councillor Connolly referred to a discussion at the previous meeting relating to a cash and carry business situated on Cook Street, Bury that had been operating without the necessary planning permission. The Borough Planning, Engineering and Transportation Services Officer reported that an Enforcement Notice had been served on the premises and a report on the matter would be submitted to the next meeting.
