## INTRODUCTION

This report presents a brief analysis of Enforcement performance for the quarterly period from 1<sup>st</sup> April 2008 to 30th September 2008.

All Enforcement Notices served and Actions taken are considered against the provisions of the Human Rights Act 1998. In taking account of whether to serve an Enforcement Notice or take Action, which is a discretionary power afforded to Councils under the Town and Country Planning Act, 1990 as amended, consideration is taken as to whether the individual's rights are affected and whether it is expedient to serve such a Notice or take Action against the individual.

The service provided currently is a reactive one in that we respond to complaints received from members of the public. The resources are not currently available to provide a more proactive service which monitors development and compliance with planning conditions.

# **CURRENT STAFFING LEVELS AND WORKING ARRANGEMENTS**

The Enforcement Team currently comprises of a Senior Planning Enforcement Officer and a Planning Enforcement Officer. The previous Planning Enforcement Officer left the Authority on 11<sup>th</sup> September 2008 and is due to be replaced on 10th November 2008. This has affected performance relating to the time taken to inspect complaints and progress cases and the number of Notices and actions taken.

Both Officers deal with complaint cases on a Borough-wide basis, in accordance with the Council's Customer Charter for the Planning Enforcement Service.

#### WORKLOAD/COMPLAINTS RECEIVED

During the period 1st April 2008 to 30<sup>th</sup> September 2008 the number of cases remain at a high level and during this period we received 349 complaints. In the full year 2007/8 we received 628 complaints and hence the number of complaints received continues to increase.

The table above includes reference to 2 performance standards in terms of the speed of the responses to a) site visits and b) cases being closed. In both cases the performance is considered to be good although there has been some impact on performance arising from the staff change.

## FORMAL NOTICES SERVED/ACTIONS TAKEN

The table above sets out statistical information for the period 1<sup>st</sup> April 2008 to 30<sup>th</sup> September 2008. During this time a total number of 23 Notices have been served and 3 prosecutions have been made. One of the prosecutions relating to the erection of unauthorised signs throughout the Bury area by a firm called Apex Self Storage, resulted in a Court appearance on 3<sup>rd</sup> November 2008. The Company pleaded Guilty and was fined a total of £8,000 plus costs.

## **CONCLUSIONS**

The number of planning Enforcement cases remains at a high level and is anticipated that the number of cases will continue to rise.

The majority of cases continue to be resolved without recourse to formal action but the marked increase in formal action being taken continues.

The service is at it its maximum effectiveness and performance without additional resources.
