SUMMARY: This report seeks approval to make a direction under Article 4 of the Town and Country Planning (General Permitted Development) Order 1995 in the form proposed to exclude permitted development rights for dwellings located within the St Mary's Conservation Area of Prestwich.

The options are as follows: **RECOMMENDED OPTION** 

- (a) To resolve to confirm 'The Metropolitan Borough of Bury St Mary's Conservation Area (Prestwich) Article 4 Direction 2009' under Article 4(2) of the Town and Country Planning (General Permitted Development) Order 1995 in the form proposed and hereby authorise the Council Solicitor to sign the Direction accordingly.
- (b) To confirm the Article 4 Direction with amendments (such amendments to be suggested by Committee).
- (c) To resolve not to confirm the Article 4 Direction.

Option (a) is recommended for the following reasons:

(1) The Article 4 Direction is an integral part of the management plan proposals approved by the

Planning Committee on 24 March 2009.

(2) The Committee resolved to make the Direction on 18 June 2009.

The final community consultation following the making of the Direction has not led to a significant objection to the proposal.

# 1.0 BACKGROUND

- 1.1 The Planning Committee approved broad proposals in connection with the Management Plan for St Mary's Conservation Area on 24<sup>th</sup> March 2009. Part of these proposals referred to legal processes being put in place to make a direction pursuant to Article 4(2) of the Town and Country Planning (General Permitted Development) Order 1995 to withdraw rights of permitted development for dwellings located within the conservation area boundary.
- 1.1 To bring an Article 4 Direction into effect involves a three stage process namely (1) making the Direction, (2) consulting upon the Direction and (3) confirming the Direction.
- 1.2 In June 2009 the Committee resolved to make the Direction and commence the consultation process (the first two stages in the process) and is now asked to confirm the Direction (as the third stage) in light of the consultation.
- 1.3 The consultation took place during June and July and involved a further advert in the local press and letters to the individual properties affected. Attached to the letter was a copy of the sealed document together with extracts from the management plan, explaining the proposals in plain English. The sealed document and a plan of the affected properties were also available for inspection at Craig House.
- 1.4 Of the 106 letters sent out 2 responses have been received. There was also a petition from 11 addresses expressing some concern over the difficulty in understanding the content of the consultation particularly the sealed document. A further letter of clarification was sent to the signatories in response to this.
- 1.5 One respondent was concerned about the consistency of planning decisions, citing the poor quality of the development at 3 Prestwich Park Road against the wish to impose unnecessary additional controls elsewhere. The respondent was also concerned over the lack of action on empty properties or those in poor condition. There was also some scepticism over the reality of the grant support, and it was suggested that the proposals overall would dissuade house purchasers in the future.
- 1.6 The other respondent raised the issue of increased cost in connection with the additional controls, and particularly the cost of repainting timber. He also

questioned the general advice to be included in the management plan, which was issued in draft as part of the consultation. Overall, he considered the proposals to be too instructive and an imposition.

1.7 Most of the concerns raised by this and previous consultations will be addressed through the implementation of the management plan. Actions are currently underway in an attempt to deal with empty properties, and those in poor condition. It is recommended that no changes be made to the Article 4 Direction and that it be confirmed in the present form.

# 2.0 ARTICLE 4 DIRECTION. PROPOSED ACTION

- 2.1 Subject to Committee confirming the direction, all affected properties will be notified, together with all parts of the Council with a direct interest in the action, and additions will be made to the Council's website. All affected properties will be photographed to provide a base record from the date the controls come into operation.
- 2.2 It is very possible that the implementation of an Article 4 Direction will lead to an additional workload for enforcement and development control staff, and for the conservation officer. Previous reports to committee have highlighted the need for Article 4 Directions in other conservation areas. Although these have been supported in principle, none are operational due to the need to develop individual schemes for each area. As part of the St Mary's Conservation Area arrangements it will therefore be prudent to monitor the impact of the changes on both staff time and on the preservation of the area's character. The level of grant applied for, approved, and claimed should also be part of the assessment. The monitoring system will be established to run for an initial period of 18 months.

# 3.0 CONCLUSION

3.1 The Article 4 Direction withdraws rights of permitted development for the St Mary's Conservation Area. This report outlines the results of the consultation authorised in June 2009. Committee is invited to confirm the Direction.
