Traffic - No objection subject to the following three conditions.

Additional Conditions

The development hereby approved shall not be first occupied unless and until the visibility improvements at the junction of the site access with Carr Street indicated on the approved plans in the form of the extension of the existing stone retaining wall and removal of affected trees and vegetation have been implemented to the written satisfaction of the Local Planning Authority.

<u>Reason</u>. To ensure the intervisibility of the users of the site and the adjacent highways in the interests of road safety.

The foundations for the extension of the existing stone retaining wall shall not encroach under the adjacent existing adopted highway at any point.

<u>Reason.</u> To ensure good highway design and to maintain the integrity of the adopted highway.

The turning facilities indicated on the approved plans shall be provided before the development is first occupied and shall subsequently be maintained free of obstruction at all times.


<u>Reason</u>. To minimise the standing and turning movements of vehicles on the highway in the interests of road safety

8 letters have been received from the occupiers of 11 Wadebridge Close; 321 Ainsworth Road; 9 Bourneville Close; 5, 7, 8, 9, 21 Bidston Close; 2 Tarleton Close; 7 Finchley Close, which have raised the following issues:

- The proposed mast would be visible above the adjacent hedgerow.
- There is no problem with O2 coverage at the site. Why is the mast needed?
- The mast should be located on a semi-rural road next to fields.
- The mast would be visible.
