I propose to extend the existing single yellow line on the south

				east side from the old Radcliffe Times Building south west to the existing shops which will prohibit vehicles parking between 8am and 7pm.  I also propose to put single yellow lines from the junction of Church Street West along both sides of Glenvale Close and put a limited waiting area in front of the hairdressing shop and Neatline furniture store. This is in response to requests from both of these businesses and Contour Housing (who manage the housing in Glenvale Close) who have all been asked for their views on the parking problems.  These proposals have to be put before the Traffic Management Unit meeting on 29 March for their approval and I will inform you of their decision in due course.
