1.0 BACKGROUND

- 1.1 The Local Government and Public Involvement in Health Act 2007 introduces the framework for significant changes to the process of handling standards allegation against Members. These changes include the devolution of the handling of such allegations from the Standards Board for England to Standards Committee. The Department for Communities Local Government is now consulting on a number of issues relating to the implementation of these changes, seeking views on specific proposals as set out in this report, by 15 February 2008.
- 1.2 The Department's intention is to implement the changes from 1 April 2008. However whilst the issues which are the subject of this Consultation are important, there are a substantial number of matters and much detail which will have to be resolved by the final regulations and guidance. Also it is equally important that sufficient time is allowed, not only for proper consultation, but for full appreciation of the regulations that are finally

published together with training of Members. Experience of past changes to the system and particularly changes to the Code of Conduct underline how important it is to get these changes right first time, rather than to rush changes into effect.

1.3 The experience of the pilot exercises is that the implementation of the "local first sieve" will require local authorities to undertake a considerable amount of additional work. The Council will receive and need to process more allegations, as currently many are filtered out by the Standards Board for England or found on investigation to be unjustified. Each of these will require an initial assessment process. From the pilot exercise it is also clear that the changes will lead to a significant increase in the number of matters going to investigation.

2.0 CONSULTATION

2.1 The specific issues on which the Department is seeking views, together with an outline response, is set out at Appendix 1 to this report for Members to consider and discuss. Members are asked to propose a final response to the Consultation, to be delegated to the Monitoring Officer for submission to the Department.
