BWTF.685 APOLOGIES

Apologies were detailed above.

BWTF.686 DECLARATIONS OF INTEREST

There were no declarations of interest.

BWTF.687 MINUTES

It was agreed.

The Minutes of the meeting of the Bury West Township Forum held on 20 November 2013 be approved as a correct record and signed by the Chair.

BWTF.688 POLICE ISSUES

PC Peachy, Sue Ecksersley and Shelly Flitcroft, Police Community Support Officers provided members of the Township Forum with a verbal update in relation to police issues in Bury West, the update contained the following information:

PC Peachy reported that there had been an increase in the number of shed burglaries reported in the Brandlesholme and Lowercroft areas. Plain clothes police officers have been dispatched to monitor the situation.

PC Peachy informed the meeting that there had been a change in legislation in relation to scrap metal collection. All persons wishing to collect scrap metal

must display a scrap metal licence in their vehicle, failure to do so could result in the confiscation of the vehicle.

PC Peachy reported that the recent changes to the way policing is conducted in the Borough has resulted in police beat officers spending less time in outlining townships and more time policing the Town Centre.

Questions and comments were invited from the Township Forum and members of the public present at the meeting and the following issues were raised:

A member of the public reported that there had been a number of instances of anti-social behaviour on Tottington Road/Hayward Street; bus shelters and cars have been vandalised. In response to the concerns raised, PC Peachy reported that he would increase patrols in the area. Members of the public were encouraged to report instances of vandalism to the police.

It was agreed:

PC Peachy, Sue Ecksersley and Shelly Flitcroft, Police Community Support Officers be thanked for their attendance.

BWTF.689 BRANDLESHOLME RESIDENTS ASSOCIATION

The Bury West Township Forum considered a verbal presentation from Philip Jones, Brandlesholme Residents Association.

It was reported that the Association had received a grant from Viridor of £75,000 to spend on a children's playground. A decision with regards to a £25,000 grant from Asda, is expected in mid January.

Phil Jones, Brandlesholme Residents Association reported that estimates for the work on the children's playground have now expired and would have to be re-tendered.

It was agreed:

A further update would be provided at the next meeting of the Township Forum meeting.

BWTF.690 BURY THIRD SECTOR DEVELOPMENT AGENCY

The Bury West Township Forum considered a verbal presentation from Derek Burke, Chief Officer, Bury Third Sector Development Agency (B3SDA), the presentation contained the following information:

B3SDA is a charity which seeks to support and develop third sector organisations, social enterprises, charities and cooperatives.

The Chief Officer reported that the B3SDA offers a range of products designed to help third sector organisations:

- A funding and organisational development service
- Volunteer centre
- Forums and networks
- Training courses and factsheets.

The Chief Officer reported that additional funding had been made available for Bury residents via the Forever Manchester initiative. The funding is available for small locally led organisations based in Bury (the Streets Ahead scheme) and the Cash4graft scheme which is designed to release small amounts of funding (between £50 and £250) for community groups of local people and neighbours who want to run local projects for the wider community benefit.

The Chief Officer reported that B3SDA also provides support to Healthwatch. Healthwatch is the new independent consumer champion for both health and social care. Healthwatch works to help local people get the best out of their local health and social services. The Chief Officer encouraged members of the Township Forum to get involved with Healthwatch either by being a member or a volunteer.

It was agreed:

Derek Burke, Chief Officer, Bury Third Sector Development Agency be thanked for his attendance.

BWTF.691 BURY WEST TOWNSHIP AREA PLAN

Christine Maksymowski, Township Co-ordinator, provided an overview of the Bury West Township Forum Area Plan. The plan outlines how the Council and its partners will continue to make progress towards the vision for Bury West to promote better outcomes for the social, health, economic and environmental wellbeing of people in the community.

Twenty young people will be interviewed in mid January for a 6 week placement which will hopefully result in an apprenticeship.

The South Partner Action Group continues to meet monthly.

A Township Forum Area Plan performance report will be developed.

It was agreed:





Case study... what this means for Betty from Bury... now

Betty is a 72 year old widow who has diabetes

She tries not to bother her GP and so held off seeing him until she was so unwell she had to go to A&E late on a Friday

She was put into observation and seen by a consultant on Monday

She stayed for 2 weeks whilst tests were done and whilst she shook off an infection

She was discharged but remained poorly and confused

A week later Betty was back in A&E for an even longer spell...

Case study... what this will mean for Betty from Bury... in the future

Betty was invited in for an assessment of her health and wellbeing

Her GP arranged for a specialist diabetes nurse to co-ordinate her care

The nurse's close links with social care meant that a personal health budget was set up to fund changes to help mobility

A tele-health system was set up in her home and now Betty's health can be monitored

If she feels ill, she has one number to call. When she did, the specialist nurse came to her home and changed her medication to keep her stable

She is living a healthy and happy life in her own home

BWTF-HSG.30 DECLARATIONS OF INTEREST

There were no declarations of interest made at the meeting.

BWTF-HSG.31 MINUTES

It was agreed:

That the minutes of the meeting held on the 17th October 2013 be approved as a correct record subject to the addition of "and then re-painted again" with reference to line painting on Bolton Road (HSG28).

MATTERS ARISING:

Speed limit review of A and B roads – The aim is to complete
within this financial year. Les Watts, Principal Engineer, reported
that the consolidation order was ready to go and legal
consultations were underway.

BWTF-HSG.32 STREET SAFE 20MPH SPEED LIMITS

The Principal Engineer provided the following update in respect of 20 mph speed limits on residential streets within Bury West:

Rudgwick Drive - Operative from October 2013 Elton Scheme - Operative from November 2013 Ashington Drive - Operative from 13 February 2014

Haig Road - Consultation process is complete. Responses

will now be evaluated to inform future report

Mr Watts informed the Group of schemes that were currently going out to consultation in the Brandlesholme east area and at the south end of Woodhill Road. Draft plans were examined by members of the Group at the meeting.

Councillor Southworth highlighted residents concerns about Hunstanton Drive being used as a cut through and requested that the road be included within the consultation.

During discussion of the issues relating to Hunstanton Drive, the Principal Engineer explained that due to the nature of the road, any scheme would require the introduction of physical measures.

In response to a suggestion by the Chair, Councillor Walker, about the potential for a chicane on Haig Road, Les Watts highlighted the cost of installation and the loss of on street parking for some residents.

With regard to the proposed scheme to the south of Woodhill Drive, Councillor Southworth highlighted the current problems faced as a result of vehicles from the company "Boomerang" taking up on street parking places.

It was reported that future schemes were planned for the Seddons Farm Estate and the Ainsworth area.

It was agreed:

That the consultations plans referred to above be noted with the following statement in respect of Hunstanton Drive:

"That a potential scheme on Hunstanton Drive will be the subject of a further consultation"

BWTF-HSG.33 HIGHWAYS ISSUES WITHIN BURY WEST

The Principal Engineer provided an update in respect of Highways issues within the Bury West area.

With regard to the planned micro asphalting works on Glenboro Avenue, it was reported the works had been delayed as a result of the weather. The wider programme had commenced this week and it is hoped that, depending on the weather, works on Glenboro Avenue will begin on 5 March 2014.

The Chair, Councillor Walker, highlighted the inconvenience to residents who had made efforts to clear the road only for the works to be postponed. Councillor Walker suggested that an explanation for the delay through the Bury Times would be a good public relations exercise and a means of keeping residents fully informed.

Who we are and what we do

Bury West Township Forum welcomes those who live, work, or have an interest in the area. The forum meets at local venues such as community centres, churches and schools. These meetings are public meetings and we strongly encourage everyone to come along. Discussions are fed back to Bury Council and its partners for appropriate action.

Bury West Township Forum is a constituted council committee consisting of all the elected members representing our area and a co-opted advisory group of local representatives from voluntary organisations and community groups. There are up to nine members on each Advisory Group and a place is also reserved for a young persons' representative.

The Forum empowers our communities, promotes the debate of local issues and brings decision making closer to our residents. It seeks to harness the many strengths and assets we have in place here in Bury West, including local groups, strong community networks, talented young people, charities and voluntary groups, to work through these issues as a strong and committed partnership.

Some facts about Bury West

Demography: Bury has a population of 185,060 (2011 Census Data), of these, approximately 21,809 live in Bury West. Bury West has an older population profile than Bury overall, with fewer under 35 year olds. Bury West has the 3rd highest life expectancy for women (82.4 years) and men (80.0 years) of all the Bury Townships.

Deprivation: In terms of measuring deprivation, England is split into small areas called lower super output areas (LSOA). Each LSOA represents approximately 1500 residents. Deprivation is measured over 7 domains: income, employment, health, disability, education and training, barriers to housing and services, living environment and crime. In England there are 32,482 LSOA. In the borough of Bury there are 120 LSOA. Each LSOA is given a ranking, with 1 being most deprived.

Daisyfield is the most deprived LSOA in Bury West. It is within the 25% most deprived in the country overall. Chantlers is the least deprived LSOA in the township, which is within the 15% least deprived LSOA in the country.

Closing the gap: Bury West is generally seen as an affluent area; however, there are clearly pockets of deprivation and inequalities, which adversely affect the life chances of many people who live in them. These inequalities between our neighbourhoods mean poorer health, lower levels of education and skills, higher crime and unemployment for people living in these areas. The Township Plan aims to help close the gap so that the lives of those in the most deprived areas are improved.

Our Assets: Bury West is a popular place to live, it has some beautiful parks and green spaces including Burrs County Park and Activity Centre, with active and enthusiastic friends groups to ensure that these spaces are well maintained. There are active Tenants and Residents Associations and an Allotment Society that are well represented on the Township Forum.

Bury West Township Forum aims to promote better outcomes for the social, health, economic, and environmental well being of people within our community.

We can achieve this by working together to achieve a number of key outcomes:

Key Outcomes:

Our Plan will contribute to the following outcomes:

Improved employment opportunities

Key Issues identified: How to help reduce the number of benefit claimants, how to increase the number of apprenticeships and pathways to work and how to create further employment locally, especially for young people.

Current Position: April 2013 there were 426 claimants in Bury West which is 9.4% of the total of claimants in Bury. 30.5% of total claimants are aged 16-24; in Elton Ward 57.6% of claimants are aged 16-24

Improved Community Safety

Key Issues identified: Some young people involved in Anti Social Behaviour (ASB).

Current Position: Youth Anti Social Behaviour is an issue in some areas of Bury West.

Improved Health and Wellbeing

Key Issues identified: Work across the Children's Centre broad agenda to support Children and Families.

Current Position: Bury West has the 2^{nd} lowest level of obesity in Reception Year and the 3^{rd} highest level in Year 6 pupils. About 1 in 12 (8%) of Reception Year Children are classified as obese. Almost 1 in 6 (18.2%) of Year 6 children are classified as obese.

Improved Educational Attainment/Learning Opportunities

Key Issues identified: The need to ensure that children are school ready.

Current Position: Some Nursery School Children are well below the expected standards and have poor communication skills.

Bury West Township Forum aims to promote better outcomes for the social, health, economic, and environmental well being of people within our community.

We can achieve this by working together to achieve a number of key outcomes:

Improved road safety and public transport

Key Issues identified: The need to discuss highways and public transport issues across the Bury West area.

Current Position: Residents have raised concerns about the volume and speed of cars on Bury West roads and inconsistency in bus services.

Improved Community Pride and Belonging

Key Issues identified: To promote the positive side of Bury West. To make more use of the parks and open spaces.

Current Position: Some residents have raised concerns about the lack of events taking place in Bury West.

Making a difference We will measure our performance as follows:

- We will monitor the action plan which will support delivery of these outcomes
 (an updated action plans will be shared at each Township Forum meeting)
- Bi-annual performance reports in relation to the above outcomes (presented to our Township Forum)
