#### LSP.406 DECLARATIONS OF INTEREST

There were no declarations of interest raised in relation to any items on the agenda.

#### LSP.407 MINUTES

#### **Delegated decision:**

That the Minutes of the Licensing and Safety Panel meeting held on 6 October 2014 be approved as a correct record and signed by the Chair.

In relation to LSP.349, Councillor Holt reported that he had met with Bury Parent Forum which is a 'not for profit' organisation, for children with special needs who require school and college transport. Unfortunately, Parents have had to make several complaints about drivers and their attitudes. Children's Services have previously arranged training for drivers and Councillor Holt requested if the Chair of the Licensing and Safety Panel, Councillor Jones, the Head of Trading Standards and Licensing and the Licensing Manager would be willing to meet with representatives of the Bury Parent Forum in order to address these issues.

The Chair, Councillor Jones, stated he would be agreeable with such a meeting, which would be arranged for the near future.

#### LSP.408 PUBLIC QUESTION TIME

Mr Charles Oakes of the Hackney Drivers' Association Ltd attended the meeting and addressed the Licensing and Safety Panel in relation to an increase in complaints from hackney drivers in relation to private hire vehicles plying for hire and dropping off and picking up from the hackney taxi ranks. Mr Oakes stated that he felt the Licensing and Safety Panel was not addressing these grievances and that he was now minded to employ a private security firm from Preston to help catch the perpetrators.

Mr Oakes also asked what the Licensing Service and Licensing and Safety Panel were doing about the ranks which were not available through being obstructed by illegally parked private cars.

The Licensing Manager reported that letters had been sent to all identified private hire drivers and operators regarding the use of hackney ranks. The Licensing Service was working with the Police in relation to the issue of private hire drivers plying for hire. A number of warnings had been issued and drivers would be brought before Panel if further breaches of their conditions continued.

With regards to additional taxi ranks, the Licensing Manager stated that it had been agreed with Highways that a trial temporary rank be available outside the Art Picture House for 18 months. For the 6 month period from 17<sup>th</sup> July when the trial commenced, objections could be received. However, it seemed that the hackney drivers were not really making use of this rank.

Mr Oakes argued that this rank was well used especially at weekends.

The Head of Trading Standards and Licensing explained that the Civil Parking Enforcement Officers do not routinely work night shifts but that the do issue a large number of fixed penalty notices to vehicles parked where they shouldn't at other times.

### LSP.411 PROPOSED SUSPENSION/REVOCATION OF A PRIVATE HIRE DRIVER'S LICENCE

The Licensing Manager presented a report submitted by the Assistant Director (Localities) regarding the Suspension/Revocation of a Hackney Carriage/Private Hire Driver's Licence.

Licensing and Safety Panel, 3 November 2014

1. Licence holder 33/2014 attended the meeting and was represented by the owner of Magnum Whiteline Taxis. The Chair outlined the procedure to be followed and the Licensing Manager read the report which was accepted by the licence holder and his representative.

#### **Delegated decision:**

Upon considering the written report, the oral representations made by the licence holder and his representative and taking account of relevant Policy and the Council's Conviction Guidelines, the Panel resolved, on a unanimous decision, that licence holder 33/2014 have his private hire driver's licence **revoked**.

The licence holder was reminded of their right of appeal to the Magistrates' Court within 21 days.

## LSP.412 APPLICATION FOR A HACKNEY CARRIAGE/PRIVATE HIRE DRIVER'S LICENCE

The Licensing Manager presented reports submitted by the Assistant Director (Localities) regarding applications for Public/Private Hire Vehicles Drivers' Licences.

The Applicants were invited to attend the meeting for separate hearings and the Chair outlined the procedure to be followed. The Applicants and their representatives were invited to address the Panel separately on their applications and any matters referred to in the Officer's report.

1. Applicant 32/2014 did not attend the meeting and had failed to attend the previous meeting of the Licensing and Safety panel on 6 October 2014, when it had been agreed to defer the hearing.

The members of the Licensing and Safety Panel therefore agreed unanimously to hear the case in the absence of the Applicant and the Licensing Manager read the report.

### **Delegated Decision:**

The Panel determined the Applicant not to be a fit and proper person in accordance with the Local Government (Miscellaneous Provisions) Act 1976 and resolved that the Applicant identified as 32/2014 be **refused** a private hire driver's licence.

The Applicant would be informed of their right to appeal to the Magistrates' Court within 21 days.

2. Applicant 34/2014 attended the meeting and was accompanied by a friend. The Licensing Manager read the report which was accepted by the Applicant.

The Applicant was reminded of their right of appeal to the Magistrates' Court within 21 days.


