#### LSP.567 DECLARATIONS OF INTEREST

#### LSP.568 MINUTES

#### **Delegated decision:**

That the Minutes of the Licensing and Safety Panel meeting held on 4 December 2014, be approved as a correct record and signed by the Chair.

#### LSP.569 PUBLIC QUESTION TIME

Mr Charles Oakes of the Hackney Drivers' Association Ltd attended the meeting and addressed the Licensing and Safety Panel in relation to the taxi rank on Market Street and the fact that this rank was not patrolled by the Civil Parking Enforcement Officers, unlike the other ranks in Bury Town Centre. Mr Oakes asked what steps could be taken in order to rectify this.

The Head of Trading Standards and Licensing explained that the difficulty arises because the Council ranks are established under differing pieces of legislation. For the older ranks established before the decriminalisation of parking offences, enforcement action is limited to Police Officers and GMP traffic wardens. For the newer ranks, enforcement action is limited to the Council contractors. On receipt of the complaint from Mr Oakes, colleagues in Traffic Management were asked for guidance but their response has not yet been received.

It was agreed to re-contact Traffic Management to explain that the matter had now been raised at the Licensing and Safety Panel, with the hope of finding a solution.

The Licensing and Safety Panel agreed to defer the matter until the next meeting.


