**P.9 PLANNING APPLICATIONS**

**61391 Land off Salisbury Road, Radcliffe, Manchester – Radcliffe North Ward**

Material amendment following grant of planning permission 58233 for residential development for 86 dwellings and associated infrastructure: Retrospective increases to finished floor levels to plots 76 – 85 and decrease to finished floor levels to plot 86
