# CA.204 PROGRESS ON IMPLEMENTATION OF THE BURY HEALTH AND SOCIAL CARE LOCALITY PLAN AND APPOINTMENT OF THE CHIEF OFFICER OF BURY CCG

The Deputy Leader and Cabinet Member for Health and Wellbeing submitted a report setting out details of the progress on the implementation of Bury's Locality Plan, the Local Care Alliance and Bury's Single Commissioning Function. As well as the financial implications of the Locality Plan for the health and social care system overall and for the Council in particular. The report also provided details

of Bury's position in relation to the standardisation of hospital services across Greater Manchester and the future of the Pennine Acute Hospitals NHS Trust.
