2 APPOINTMENT OF CHAIR

It was agreed:

4 MINUTES OF THE LAST MEETING

6 BURY'S SCHOOL FORUM REPRESENTATION - JANUARY 2023 CENSUS

Alison Vidler presented Bury Schools' Forum Representation – January 2023 Census report.

A question was raised regarding the membership of the Forum and the vacancies that required filling.

It was explained that there were some vacancies and requests to fill these would be taken through BASH and BAPH and the Headteachers Forum and the Governor's Forum.

It was also reported that the Union Members came under the Teacher Professional Association category.

NATIONAL FUNDING FORMULA - PLANNED REMOVAL OF RECEPTION UPLIFT

Alison Vidler presented the National Funding Formula – Reception Uplift report.

The following comments and questions were received:

• Simon Waddington asked whether the money would still remain with the Local Authority?

It was explained that this was the case, the money would remain in schools block to be allocated another way.

• It was asked whether there would be a local opportunity to add in.

It was reported that notice from the DFE was expected in relation to removing the current flexibility of applying the uplift.

8 DEDICATED SCHOOLS GRANT (DSG) DEFICIT POSITION 2022/2023

Isobel Booler presented the Dedicated Schools Grant (DSG) Deficit Position 2022/23 report.

• It was asked whether there would be clawback for schools with surplus.

It was explained that the clawback had been carried out after taking into account the use of balances for 2022/2023.

It was asked whether there were any patterns in relation to the schools in deficit.

It was explained that all schools had been affected by the increase in energy costs .

It was also explained that there were falling rolls currently and an older population in the north of the borough which was forecast to continue with a younger population to the south and more popular schools. Analysis was ongoing in relation to this.

A report would be brought to a future meeting of Schools' Forum in relation to school rolls.

DSG DEFICIT RECOVERY - PROGRAMME SAFETY VALVE (PSV)

Isobel Booler, Director of Education and Skills gave a presentation updating the Schools' Forum on Project Safety Valve.

The presentation explained:

- Where PSV was currently,
- The strategies that were in place to make sure that all PSV spending was correct and being allocated as required.
- Work being done to maximise income
- Work being done to reduce unit costs including removing Band D plus, Inclusion funding, new provision due to come on line
- Challenges from the DFE
- The Safety Valve agreement
- Number of SEN assessments and education and work being done to reduce them.

Those present were given the opportunity to ask questions and make comments and the following points were raised:-

- It was explained that the special schools in the borough had taken the brunt of PSV but had been affected by the rises in SEN cases for years with Elms Bank School and College pupil number increasing from 116 to 300 over the years.
- It was suggested that all headteachers should be brought together to discuss the issues raised and it was suggested that this request be taken through BASH and BAPH.
- The need to focus on early years assessments.
- Work to ensure that children stay in mainstream provision.

- Early help 0 5 intervention.
- Connecting Health and Social Care provision and how systems talk to each other including nurseries talking to schools.
- Giving early years the tools to support colleagues.
- What training packages could be shared.

It was reported that a Management Plan was due to be completed by the end of the month. The draft plan would be presented to the DFE at the end of the week after which a meeting with the DFE would be taking place prior to the plan being submitted.

* Indicative Growth and Falling Rolls Funding shown above is calculated on May 2023 census adjusted with September admission numbers for existing schools and a lump sum for the new Free School. The final allocation will be confirmed by the DfE in December 2023.

2 Formula Unit Values

Schools' Forum is required to recommend the formula unit values to be applied to all Mainstream Schools & Academies funding allocations on an annual basis.

The formula unit values applied to Bury Schools and Academies funding formula already directly mirror the DfE National Funding Formula (NFF) unit values. For 2024-25, the Split Site Factor is compulsory for all local authorities.

RECOMMENDATION 1:

Schools' Forum (all members) recommends all the unit values specified in the table above, to be applied in compliance with the National Funding Formula (NFF) to Bury's Mainstream schools and academies funding formula for 2024-25.

3. De-delegation

For maintained mainstream schools only, the formula mechanism contains options for schools to choose to de-delegate an amount from their formula allocation to contribute to Local Authority services that work to support them. Academies can buy back into any of these services.

Schools' Forum (Maintained Mainstream only) is required to recommend the Dedelegated items each year. The table below proposes the level of de-delegation to be recommended for 2024-25.

RECOMMENDATION 2:

Schools' Forum (maintained school representatives) recommends the de-delegated values for 2024-25, summarised as follows:

- Schools of Concern @ £6.62 per pupil
- Free School Meals Eligibility Checking @ £5.51 per FSM6
- Trade Union Facilities Time @ £4.41 per pupil
- School Improvement Brokerage and Monitoring Grant @ £15.75 per-pupil
- 4. Minimum Funding Guarantee (MFG)

The statutory guidance allows local authorities to set a pre-16 MFG in their local formulae, to protect schools from excessive year-on-year changes.

Local authorities will be able to set an MFG between +0.0% and +0.5% per pupil.

RECOMMENDATION 3:

Schools' Forum (all members) recommends that the MFG protection is set at +0.5% in line with DfE guidance.

5. Headroom

After all formula factors have been updated as per the above recommendations and in accordance with the National Funding Formula unit values, there is a balance of DSG Schools Block that remains un-allocated. This balance is required to cover any outstanding updates to budget determinations as follows:

- October 2023 census variations Pupil numbers will be adjusted for in the final Schools Block determination, however any increases in funding required due to variances in pupil cohort characteristics need to be covered from any available headroom monies, for example if increased deprivation funding is required once all up to date pupils have been mapped into the respective factors.
- Growth where increased pupil intakes require additional classes to meet infant class size regulations, or to meet Basic Need requirements, funding needs to be either retained to fund in-year growth or estimated upfront within school budget allocations where data is known about planned growth prior to the final budgets being determined and published.

Growth funding will specifically be needed for the new free school due to open in Radcliffe in September 2024.

- Falling Rolls Fund funding may be set aside from the Schools Block to create a small fund to support good schools with falling rolls, where local planning data shows that the surplus places will be needed within the next three financial years.
- Minimum funding Level (MFL) and Minimum Funding Guarantee (MFG) protections – once all final data has been input there may be increased protections required on individual school budgets to ensure their actual budget allocations comply with the MFL and MFG funding per-pupil levels and protections.

If, when all items above have been updated to reflect the actual individual schools budget determinations, and any amounts to support growth and falling rolls have been allocated, there remains a balance of unallocated Schools Block funding, the Local Authority will factor a transfer of this balance by way of supporting the deficit recovery to the High Needs Block.

Schools' Forum may recommend up to 0.5% transfer of Schools' Block without any disapplication process being required to be approved by the Secretary of State for Education. For information, 0.5% of Bury's 2024-25 indicative Schools Block is circa £791,700.

A 0.5% transfer to the High Needs Block has been factored into future years as part of DSG Safety Valve Management Plan submitted to the DfE.

If there is insufficient Headroom once all other updates have been completed, then Schools Forum may need to consider how to balance the overall Schools Block by reviewing all formula factors.

5a Growth Funding

The Local Authority is required to set criteria for the allocation of growth funding.

The growth fund can only be used to:

- Support growth in pre-16 pupil numbers to meet basic need.
- Support additional classes needed to meet the infant class size regulation.
- Meet the costs of new schools.

The growth fund must not be used to support:

- Schools in financial difficulty.
- General growth due to popularity; this is managed through lagged funding. This includes cases where academies have admitted above the pupil admission number (PAN) by their own choice.

The primary growth factor value for 2024-25 is £1,550.

Funding for maintained schools is provided to cover the period from September to March before the lagged funding system 'catches up' from the subsequent April through the subsequent year's NFF. Since academies are funded on an academic year basis, they would receive additional funding (at a rate of an additional five sevenths of the allocation) to cover a full year's growth funding before the system 'catches up'.

RECOMMENDATION 4:

Schools' Forum (all members) recommends the criteria below for allocating growth funding.

Growth fund allocations will be made for LA approved bulge classes in the first year, or for LA agreed expansion classes as the expansion moves up the school.

These will be funded from the centrally retained growth fund. Funding for new classes will be set above the minimum funding expectation set by DfE.

Growth funding will be allocated as follows:

primary growth factor value x number of pupils x ACA

The primary growth factor value will be used for all school types recognising there is one teacher pay scale and that this funding is a minimum value.

RECOMMENDATION 5:

Schools' Forum recommends the use of Headroom to address all outstanding items outlined above and a transfer of any balance, up to a maximum of 0.5%, of unallocated Schools Block Headroom to the High Needs Block, the amount to be confirmed at the meeting of Schools' Forum in January 2024.
