1 WELCOME AND APOLOGIES

The Chair welcomed all to the meeting. Apologies were received from Cllr Green.

2 DECLARATIONS OF INTEREST

There were no Declarations of Interest submitted.

3 MINUTES OF THE LAST MEETING & ANY MATTERS ARISING

It was agreed that:

The Minutes of the last meeting held on 3rd April 2024 be approved as a correct record.

4 UPDATE ON TWO YEAR TERM OF OFFICE FOR INDEPENDENT PERSONS AND RECRUITMENT

Jacqui Dennis, the Council's Monitoring Officer, verbally updated Members on the Term of Office for the two Independent Persons and also provided an update on the recruitment process for the third Independent Person.

The Monitoring Officer confirmed that the two existing Independent Persons, Craig Ainsworth and Stuart Birtwell's terms of office had been extended for two years, effective from the Annual Council meeting in May. It was also advised that recruitment of a third person to help improve gender balance had not been successful, despite advertisement in the Bury Times and on social media.

The Committee discussed the matter and requested that the Monitoring Officer advertise the post again via social media and other channels.

It was agreed that:

- 1. The two year term for the Independent Persons be noted; and
- 2. That the Monitoring Officer progress advertising for the third Independent Person, using appropriate channels.

5 WORK PROGRAMME 2024-25

The Monitoring Officer presented the proposed Work Programme for 2024-25 for consideration by Members.

Members discussed the Council's training offer, both in person and on-line training and mandatory/core training, as well as the Leadership Offer (including LGA support) with the Monitoring Officer confirming that this was a matter for the Member Development Group, but that a report on the core training available and attendance/completion could be submitted to the Standards Committee.

It was agreed:

- 1. That the Work Programme as submitted be agreed; and
- 2. That a report on the training offer containing attendance/completion information be submitted to a future meeting of the Committee.

6 LOCAL GOVERNMENT AND SOCIAL CARE OMBUDSMAN ANNUAL REVIEW LETTER 2023-24

At this point of the Meeting, the Panel moved into Part B, having resolved under Section 100 (A) (4) of the Local Government Acy 1972 that the press and be public be excluded from the meeting during consideration of this item of business since it involved the likely disclosure of exempt information as stated.

The Committee discussed the Annual Review Letter 2023-24 from the Local Government & Social Care Ombudsman, which was publicly available, highlighting:

- 88% of complaints investigated were upheld, with 23 upheld decisions.
- In 92% of cases the Ombudsman was satisfied that the organisation had successfully implemented recommendations.
- In 9% of upheld cases the Ombudsman found the organisation had provided a satisfactory remedy before the complaint reached the Ombudsman.

The letter advised that during the year, two public reports about your Council the Council had been published. Both reports followed two previous investigations where the Council had agreed to update both its transport to education policy for young adults with special educational needs, and its policy on arranging education for children who were unable to access their normal provision. In both cases the Council did not implement the agreed recommendations, and the Ombudsman published the reports to highlight this.

The Ombudsman was pleased to note however that to note the Council had now implemented all the agreed actions and has reviewed both policies. It also noted the positive work carried out consulting on the draft policy for school transport, which included engaging with parent groups and other stakeholders.

In terms of the Council responding late to Ombudsman enquiries or provide incomplete responses, the Ombudsman welcomed the significant strides the Council had now made to improve its complaint functions, with the Monitoring Officer leading a centralised complaints team that oversaw all casework and compliance, and additional oversight and accountability provided by the Scrutiny Committee.

The Ombudsman was pleased to report that there were clear signs of improvement in the Council's performance; and in the final months of the reporting year, no reports had been received about delayed or incomplete responses to enquiries, and compliance with recommendations was being achieved in 100% of cases. The Ombudsman would continue to meet with the Council over the coming months to continue to monitor performance and provide support where needed.

Members of the Panel discussed the Letter and confidential appendices and noted the improving position, whilst noting the high number of SEND and EHCP assessments, which impacted on the complaints process.

The Monitoring Officer reported on a focus on improvements relating to compliance, and that proposals relating to the adoption of the Complaints Handling Code would be presented before 2026.

At this point of the Meeting, the Committee moved back into Part A.

It was agreed:

a) That the content of the Ombudsman's Annual Review Letter to the Council be noted; and: (b) That the complaints made to the Local Government Ombudsman referred to the Council during 2023/24 and their outcomes be noted.

7 MEMBER ATTENDANCE STATISTICS

Members discussed the report submitted, and noted some discrepancies in the attendance figures, so it was agreed that a revised report would be submitted to the next meeting.

It was agreed:

That a revised report be submitted to the next meeting.

8 COMPLAINTS UPDATE

The Monitoring Officer verbally reported that there had been 22 complaints since the last Committee, and gave details of the complaints, many of which related to the same incident, and others were election related, with two involving social media. None of the complaints were upheld.

Members discussed the update and also referenced the Code of Code training that covered Social Media guidance.

It was agreed:

That the update be noted and the Social Media guidance be re-issued.

Executive Summary:

This report sets out the terms of reference and methodology for previous Independent Review Panel (IRP) to assist in determining the terms of reference and methodology for the IRP 2024/2025.

Recommendation(s)

Members are asked to give consideration to the terms of reference to the Independent Remuneration Panel and the methodology for the review.

Background

The current Members allowance scheme was agreed by Members in November 2021 and was implemented in May 2022. The current scheme sets out the allowances payable to Members including a basic allowance, additional responsibility allowances, carers and travel and subsistence allowances. The scheme also set out the amounts that can be paid to co - optees and Independent Persons. Updated Members Allowance Scheme May 2021.pdf

It is important the allowance scheme is regularly reviewed. The level of allowances payable under this scheme is increased annually at the same rate as the pay award agreed by the Joint Council for Local Government Services. Indexation runs for four years (2022-2026), which is the maximum length of time permitted by the 2003 Regulations.

All Councils are required to convene their IRP and seek its advice before they make any changes or amendments to their Members' Allowances Scheme. They must 'pay regard' to their IRPs recommendations before setting a new or amended Members' Allowances Scheme. It is this requirement that provides an opportunity for IRPs to publicly scrutinise their Councils' allowances schemes and enhance public accountability.

These regulations, which arise out of the relevant provisions contained in the Local Government Act 2000, require all local authorities to establish and maintain an advisory Independent [Members] Remuneration Panel to review and provide advice on Members' allowances on a periodic basis. Bury has a panel which is made up of Dr Declan Hall, Andrew Roberts and John Thompson.

It is proposed that the IRP review the current scheme with a view to reporting back to Members summer 2025.

The review in 2021 considered the following -

- To make recommendations to the Council as to the amount of Basic Allowance that should be payable to its elected members.
- To make recommendations to the Council about the responsibilities or duties which should lead to the payment of a Special Responsibility Allowance and the amount of such an allowance.
- To make recommendations to the Council about other allowances including care of children and other dependents, travel and phone.
- To make recommendations to the Council about the level of allowance paid to coopted members of the Council's Audit Committee and independent members of the Standards Committee.
- To make recommendations on the level of allowance paid to the Mayor and Deputy Mayor for the purpose of meeting the expenses of those offices (ie the Mayoral Allowance).
- To make recommendations on the payment of member(s) appointed to the Greater Manchester Combined Authority (GMCA) in respect of duties and responsibilities undertaken as a member of the GMCA, and if so to specify the amount of any such allowance.
- To consider the level of Travelling, utility and Subsistence Allowances for members of Independent Education Appeals Panels.

Are there matters which Members would like the IRP to consider. In addition to the above the IRP considered carers allowances. Child care and caring responsibilities have been seen as a barrier to members of the public wishing to become a Councillor. This Council has recently adopted a maternity/paternity leave policy to supplement the members allowance scheme.

The methodology for the earlier review was as follows -

- The Panel seeks the views of Members both written and oral, with an opportunities for selected Members to meet the Panel
- Factual Briefings from Officers
- The Statutory Guidance on Regulation for Local Authority Allowances 2006.
- The 2003 Members' Allowances Regulations
- Roles and Responsibilities as contained within the Council's Constitution
- That recommendations should conform to existing legislation and anticipate likely future legislation so far as possible.
- The requirement for their report and recommended changes to the scheme of allowances to be easy to understand and adequately justifiable to the electorate. To assist in its deliberations, as background information it is suggested that the Panel be provided with comparative information from other GM authorities.
- A questionnaire was sent to all Members to obtain their views.

Would Members like to recommend changes to this methodology. On the earlier review a number of Members were interview including Leaders, Chairs of Committees and a cross section of Members not holding areas of additional responsibility.

Councillors in the news '24

West Suffolk Council - Serious breach of conduct rules, including bullying, discrimination and harassment July '24

- Two Councillors breached six rules of the councillors' code of conduct
- Both councillors breached rules relating to bullying, disclosing confidential information, using their positions to the advantage or disadvantage of themselves or anyone else, and bringing their role or local authority into disrepute.
- One of the councillors also broke rules relating to harassment and treating other councillors and members of the public with respect.
- One of the councillor broke rules relating to respect for volunteers and employees of the council or other partner organisations, and discrimination unlawfully against a person.
- Sanctions imposed on them include writing a letter of apology to complainants.
- One councillor will be removed from his seat on the officer appointments committee and as leader of their group.

Worcestershire - Former county council chairman found guilty of gross misconduct in police role July '24

- A SPECIAL constable and councillor who posed as a woman on social media to exchange explicit images with men has been found guilty of gross misconduct.
- A former chairman of Worcestershire County Council, used a fake Facebook profile to contact multiple men, a Warwickshire Police misconduct panel heard on June 28.
- The 26-year-old claimed he was 'having a joke' but the hearing found those involved had been deceived. The panel found he had breached the standards of professional behaviour in respect of honesty and integrity, and discreditable conduct.
- The Councillor had been a county councillor since November 2019 and chairman since May 2023. He stepped down from his role as chairman on May 16

Dacorum Borough Council - Former Council leader suspended following misconduct allegations — July '24

- An investigation has been launched by the council to examine misconduct claims made against the politician, who was also the local Group leader.
- Alleged misconduct
 - failed to treat the complainants with respect;
 - constituted harassment;
 - failed to promote equalities as required by the Code of Conduct;
 - and actions and behaviours had the potential to bring the Council into disrepute
- Both complaints dismissed at the Standards committee on 12th September 2024 on the basis that
 - The Complaint is insufficiently particularised
 - not satisfied on the balance of probabilities, that the alleged factual allegations occurred
 - was not satisfied that the facts amount to a breach of the Code of Conduct.

Vale of Glamorgan - Councillor to face disciplinary hearing after misconduct claim – July '29

- Councillor facing standards committee for breach of the members' code of conduct including failing to provide the council with accurate information in a business grant application using their council email for private business matters and acting improperly in sending emails for their benefit and their spouses personal business interests.
- Public Services Ombudsman for Wales (PSOW) is alleging a failure to comply with 7 sections of the members' code of conduct.
- PSOW investigation report: "The council's internal audit investigation concluded that the
 member failed to provide the council with accurate information, attempted to gain grant
 funding when it was apparent claims were not justified failed to inform or undate the
 council in respect of the occupancy and therefore business rates liability for particular
 properties provided contradictory information when applying for grant funding made
 enquiries for grants and misled the council, and caused an eligible company to miss out
 on a grant to which it was entitled.
- "The ombudsman considered that the serious and concerning findings of the council's
 internal audit investigation gave rise to concerns about the member's conduct which
 appears to have been contrary to the principles which govern the conduct of members
 which required the member to act with selflessness, honesty, integrity and in the public
 interest."

West Norfolk - Councillor facings allegations of misconduct storms out of meeting – July '24

- A councillor facing allegations of misconduct has stormed out of a hearing being conducted in secret claiming it is being carried out "unlawfully" when the panel refused their request for two representatives (legal advisors) to sit in on the discussions.
- Allegations relate to correspondence between the Councillor and senior officers and other councillors.
- The meeting continued in the councillor's absence and members voted to exclude the press and public.
- The decision for it to be held in private was due to the hearing disclosing exempt information relating to individuals not present at the meeting and who would not have the ability to defend themselves.
- Following the Councillors walkout, he was not be able to defend himself either at the hearing.
- As part of the reprimand he was required to stand down from his roles on the standards committee and the investigations and disciplinary committee, which he set up
