Following the approval (1515) to establish a sustainable tennis facility at St Marys Park across all four courts, with a 40k joint capital investment between Bury Council and the Lawn Tennis Association (LTA) the court re-development opportunity invited competitive tenders from contractors advertised to listed Communities and Wellbeing suppliers.

Access System

The Lawn Tennis Association (LTA) has worked in conjunction with CIA Fire & Security Ltd (CIA) in expanding its established online club system (clubspark) by integrating authorised access control on tennis courts. The scheme will aid flexible venue management and control, providing a tool to promote our tennis court facilities.

Although the access system unit and installation is funded by the LTA at circa 6k, the power requirements are the responsibility of Bury Council, which was not accounted for in the initial capital project scope or budget estimates.

It is recommended that the electrical contract is awarded to Groundwork Landscapes Limited.

Despite omitting the fencing replacement from the initial re development budget to minimise total project costs, it was apparent that new fencing would in fact be required to meet the specification of the Access System gate installation.

A revised quotation to accommodate our request for only replacing a single fencing elevation due to current budget constraints is accommodated by Groundwork Landscapes Ltd. The remaining fencing will be accounted for within the approved ring fenced surplus monies as part of the long term sustainability and development of St Marys Park from revenue generated through the access system model.

Taking these two new items into account the revised project total of £47,217.30 leaves a shortfall of £7,217.30 against the forecasted budget of £40k due to the new access gate power requirements at £2145+vat and front elevation fencing replacement £4875+vat.

A further £5K funding has been made available through Bury Council and a further £2k funding has been made available through the LTA. The remaining balance of £217.30 will be accounted for in the St Marys Park pilot project cash flow.

No additional council funding is required.
