Para 64 of the revised NPPF states that where major development involving the provision of housing is proposed, planning policies and decisions should expect at least 10% of the homes to be available for affordable home ownership.

As such, the Section 106 agreement would be amended to ensure that the 15 affordable houses are available for affordable home ownership.

Clarification of the Description of the proposal -

To omit the condition to implement a Traffic Regulation Order and to vary the condition to retain the cycle lane with additional signage to be provided.

Amended wording - condition 5. Given the use has already commenced the following wording is more appropriate.

Within six weeks of the date of this decision, the footway improvements on the Manchester Road site boundary shown indicatively on the approved plans, incorporating the removal of existing bitmac radii, provision of a full height kerb and flagged footway, demarcation of the limits of the adopted highway, all associated

highway remedial works, provision of boundary treatment to the outside seating area clear of the new footway and accommodation and drainage works on the private forecourt to provide a level access to the premises and mitigate the discharge of surface water onto the highway/into the premises, have been implemented to a specification agreed with the Local Planning Authority.

<u>Reason</u>. To ensure good highway design and maintain the integrity of the adopted highway in the interests of highway safety pursuant to UDP Policy HT2 Highway Network and HT6/1 Pedestrian and Cyclist Movement.





Rev A: External stairs amended gff 15.06.18




