- (i) Close Bridge Street to traffic between Bolton Street and Crow Lane
- (ii) Close Square Street to traffic between Smithy Street and Bridge Street
- (iii) Close Silver Street to traffic from Bridge Street for a distance of 70 metres in a southerly direction
- (iv) Close Union Street, Ramsbottom to traffic full length between Railway Street and Prince Street
- (v) Close Palatine Street, Ramsbottom to traffic between Bridge Street and King Street
- (vi) Close Prince Street, Ramsbottom to traffic between King Street and Union Street

ROAD TRAFFIC REGULATION ACT 1984, SECTION 16A THE METROPOLITAN BOROUGH OF BURY (VARIOUS ROADS, RAMSBOTTOM – RAMSBOTTOM CHOCOLATE FESTIVAL) TEMPORARY CLOSURE AND PROHIBITION OF WAITING ORDER 2019

The Council of the Metropolitan Borough of Bury being satisfied that vehicles in the length of street referred to below should be restricted by reason of an event taking place in the length of street pursuant to Section 16A of the Road Traffic Regulation Act 1984 and of all other enabling powers hereby make the following Order:-

- i until the said event is completed no person shall except upon the direction of or with the permission of a Police Constable or a Civil Enforcement Officer in uniform cause or permit any vehicles to proceed along the length(s) of street(s) as specified in the Schedule 1 below
- ii until the said event is completed no person shall except upon the direction of or with the permission of a Police Constable or a Civil Enforcement Officer in uniform cause or permit any vehicles to wait at any time along the length(s) of street(s) as specified in Schedule 2 below
- iii The Metropolitan Borough of Bury (Smithy Street/Silver Street/Square Street, Ramsbottom) (One-Way Traffic, Restriction of Waiting and Revocation) Order 1989 shall have effect as though Paragraph 1 of Schedule 1 is hereby temporarily revoked
- iv The Metropolitan Borough of Bury (Crow Lane, Ramsbottom) (Weight Restriction) Order 1996 is hereby temporarily revoked
- v The Greater Manchester County (Ramsbottom Area) (Traffic Regulation) (No. 1 (Borough) Order 1978 shall have effect as though Schedule 3 (as amended) is hereby temporarily revoked
- vi the Interpretation Act 1978 shall apply for the interpretation of this Order as it applies to the interpretation of an Act of Parliament
- vii Nothing in Article (i) and (ii) renders it unlawful to cause or permit any vehicle to wait on any of the sides of the lengths of the road referred to in that Article as long as is necessary to enable the vehicle to be used for fire brigade, ambulance or police purposes.
- viii this Order shall come into operation on Saturday 06 April 2019 and will remain in force for a period of 2 days and may be cited as The Metropolitan Borough of Bury (Various Roads, Ramsbottom Ramsbottom Chocolate Festival) Temporary Closure and Prohibition of Waiting Order 2019




