### **Details of Operational Decision Taken** [with reasons]:

An opportunity inviting qualified 'Economic Operators' to Tender was placed on the procurement portal, The Chest in accordance with Contract Procedure Rule 4.1 with 3 organisations submitting bids by the required closing date.

Following evaluation and scoring of the submitted tenders it is recommended that:

## Sportsafe UK LTD

2 Moorside Eastgate Colchester Essex CO1 2TJ

Is accepted as the supplier providing best overall value to the Council in the sum of £13,984.50. Funding for this has already been set aside for this within the Leisure Reserve.

Please see the attached supporting document for further details.

#### Rationale for purchase.

The existing rebound/dividing boards are over 10 years old and have been moved/repositioned at least 4 days per week over this period. The boards are heavy and cumbersome.

Whilst temporary repairs have been made where necessary, this is no longer a viable option. The boards themselves have holes and visible damage to them which affect the integrity of the structure. On the board attachments, the metal fittings have twisted rendering them unsafe as the boards can no longer fit securely, therefore more prone to being dislodged during use i.e. 5 a side football.

If dislodged during use there is potential of serious harm to customers as the board serves as a barrier between various sporting activities.

Floor anchor points are also no longer fit for purpose, resulting in significant movement of the boards from the base upwards.

The wheel mechanisms are showing signs of significant wear and tear which impacts on the transport of the board – damaging the floor and posing a manual handling risk for management and staff.
