## **METROPOLITAN BOROUGH OF BURY**

### **ROAD TRAFFIC REGULATION ACT 1984, SECTION 16A THE METROPOLITAN BOROUGH OF BURY (VARIOUS ROADS, BURY, TOTTINGTON AND RAMSBOTTOM – IRONMAN, BOLTON – TRIATHLON EVENT) TEMPORARY CLOSURE, ONE WAY AND TEMPORARY PROHIBITION OF WAITING ORDER 2019**

The Council of the Metropolitan Borough of Bury being satisfied that vehicles in the length of street referred to below should be restricted for the purposes of event and public safety in facilitating the holding of a relevant event (Ironman UK, Bolton Triathlon Event) and being satisfied that it is not reasonably practicable for the event to be held otherwise than on a road pursuant to Section 16A of the Road Traffic Regulation Act 1984 and of all other enabling powers hereby makes the following Order:-

- 1) until the said event is completed no person shall except upon the direction of or with the permission of a Police Constable or a Civil Enforcement Officer in uniform cause or permit any vehicles to proceed along the length(s) of street(s) as specified in Schedule 1 below, between the hours of 07.00 and 14.30 on Sunday 14 July 2019
- 2) until the said event is completed no person shall except upon the direction of or with the permission of a Police Constable or a Civil Enforcement Officer in uniform cause or permit any vehicles to proceed along the length(s) of street(s) as specified in Schedule 2 below, between the hours of 07.00 and 15.00 on Sunday 14 July 2019
- 3) until the said event is completed no person shall except upon the direction of or with the permission of a Police Constable or a Civil Enforcement Officer in uniform cause or permit any vehicles to proceed along the lengths of street(s) as specified in Schedule 3 in the direction specified, between the hours of 7.00 and 14.30 on Sunday 14 July 2019
- 4) until the said event is completed no person shall except upon the direction of or with the permission of a Police Constable or a Civil Enforcement Officer in uniform cause or permit any vehicles to proceed along the lengths of street(s) as specified in Schedule 4 in the direction specified, between the hours of 07.00 and 15.00 on Sunday 14 July 2019
- 5) until the said event is completed no person shall except upon the direction of or with the permission of a Police Constable or a Civil Enforcement Officer in uniform cause or permit any vehicles to wait, load/unload along the length(s) of street(s) as specified in the Schedule 5 below, between the hours of 19.00 on Saturday 13 July 2019 and 14.30 on Sunday 14 July 2019
- 6) until the said event is completed no person shall except upon the direction of or with the permission of a Police Constable or a Civil Enforcement Officer in uniform cause or permit any vehicles to wait, load/unload along the length(s) of street(s) as specified in Schedule 6 below, between the hours of 19.00 on Saturday 13 July 2019 and 15.00 on Sunday 14 July 2019
- 7) the Interpretation Act 1978 shall apply for the interpretation of this Order as it applies to the interpretation of an Act of Parliament

- 8) the reason for the proposed Order is to control traffic movement and assist in public safety to facilitate the holding of the Ironman Bolton Triathlon Event on Sunday 14 July 2019
- 9) Nothing in Articles 1 to 6 of this Order shall apply to event participants and supporting vehicles, emergency vehicles and any vehicle engaged in the operation of the event and in relation to the implementation, removal or enforcement of the restrictions introduced pursuant to this Order.
- 10) Nothing in Articles 1 to 6 of this order shall apply to vehicles engaged in providing care services and granted access with the assistance of the event organisers, where safe to do so, or any other such vehicles granted essential access and with the assistance of the event organisers
- 11) this Order shall come into operation on Saturday 13 July 2019 and will remain in force for a period of 2 days and may be cited as The Metropolitan Borough of Bury (Various Roads, Bury, Tottington and Ramsbottom – Ironman, Bolton – Triathlon Event) Temporary Closure Order 2019

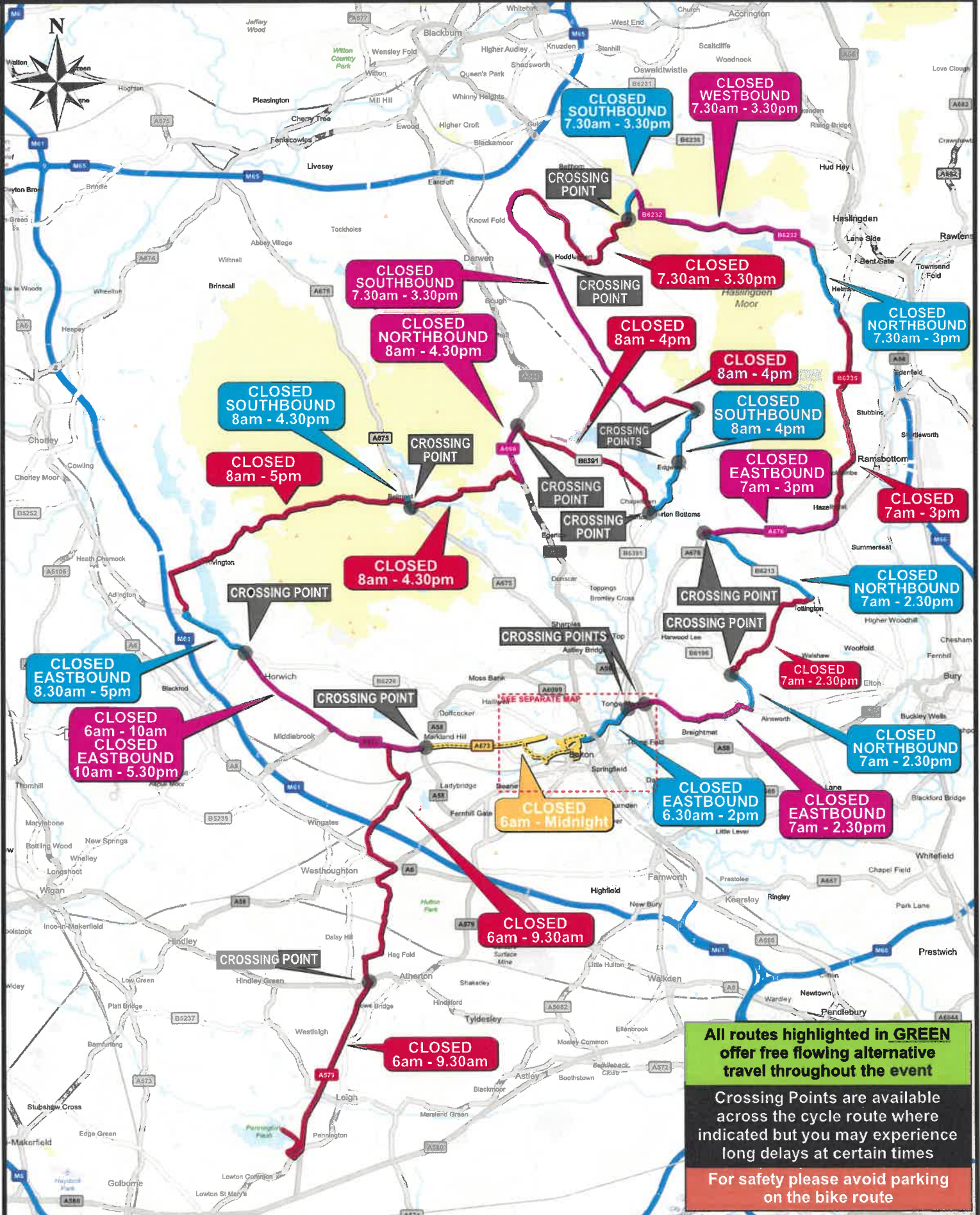
