ROAD TRAFFIC REGULATION ACT 1984, SECTION 16A THE METROPOLITAN BOROUGH OF BURY (VARIOUS ROADS, RAMSBOTTOM, HAWKSHAW AND TOTTINGTON, BURY – TOUR OF BRITAIN – CYCLING EVENT) TEMPORARY CLOSURE AND TEMPORARY PROHIBITION OF WAITING/LOADING/UNLOADING ORDER 2019

The Council of the Metropolitan Borough of Bury being satisfied that vehicles in the length of street referred to below should be restricted for the purposes of event and public safety in facilitating the holding of a relevant event (Tour of Britain, Cycling Event) and being satisfied that it is not reasonably practicable for the event to be held otherwise than on a road pursuant to Section 16A of the Road Traffic Regulation Act 1984 and of all other enabling powers hereby makes the following Order:-

- 1) until the said event is completed no person shall except upon the direction of or with the permission of a Police Constable or a Civil Enforcement Officer in uniform cause or permit any vehicles to proceed along the length(s) of street(s) as specified in Schedule 1 below, between the hours of 10.00 and 16.00 on Saturday 14 September 2019
- 2) until the said event is completed no person shall except upon the direction of or with the permission of a Police Constable or a Civil Enforcement Officer in uniform cause or permit any vehicles to wait, load/unload along the length(s) of street(s) as specified in the Schedule 2 below, between the hours of 10.00 and 16.00 on Saturday 14 September 2019
- 3) the Interpretation Act 1978 shall apply for the interpretation of this Order as it applies to the interpretation of an Act of Parliament
- 4) the reason for the proposed Order is to control traffic movement and assist in public safety to facilitate the holding of the Tour of Britain Cycling Event on Saturday 14 September 2019
- 9) Nothing in Articles 1 and 2 of this Order shall apply to event participants and supporting vehicles, emergency vehicles and any vehicle engaged in the operation of the event and in relation to the implementation, removal or enforcement of the restrictions introduced pursuant to this Order.
- 10) Nothing in Articles 1 and 2 of this order shall apply to vehicles engaged in providing care services and granted access with the assistance of the event organisers, where safe to do so, or any other such vehicles granted essential access and with the assistance of the event organisers
- 11) this Order shall come into operation on Saturday 14 September 2019 and will remain in force for a period of 2 days and may be cited as The Metropolitan Borough of Bury (Various Roads, Ramsbottom, Hawkshaw and Tottington, Bury Tour of Britain Cycling Event) Temporary Closure and Temporary Prohibition of Waiting/Loading/Unloading Order 2019





REQUEST FOR CONSENT TO TEMPORARY ROAD CLOSURES UNDER SECTION 16B OF THE ROAD TRAFFIC REGULATION ACT 1984 THE METROPOLITAN BOROUGH OF BURY (VARIOUS ROADS, RAMSBOTTOM, HAWKSHAW AND TOTTINGTON, BURY – TOUR OF BRITAIN – CYCLING EVENT) TEMPORARY CLOSURE AND TEMPORARY PROHIBITION OF WAITING/LOADING/UNLOADING ORDER 2019

I refer to your correspondence of 17 July.

The Secretary of State for Transport hereby agrees, by authority of section 16B of the Road Traffic Regulation Act 1984 ("the 1984 Act"), that an Order relating to a temporary traffic restriction, when made by your Council under section 16A of the Act, can continue in force on 14 September 2019 in order to facilitate the Tour of Britain event.

The highways to be restricted/closed to traffic are all as stated in the draft Order.

You are reminded that the published Order cannot, at any time, prevent access for pedestrians to any premises situated on or adjacent to the road or to any other premises accessible for pedestrians from, and only from, the road.
