1 Introduction

- 1.1 The Greater Manchester authorities have to submit an Annual Status Report (ASR) to DEFRA on progress made against the GM Air Quality Action Plan.
- 1.2 The report attached at Appendix 1 has been produced by the Air Quality Working Group. It sets out the measures TfGM, and the 10 GM authorities, have undertaken to improve air quality. They relate to the actions in the GM Air Quality Action Plan which the Combined Authority signed off in December 2016.
- 1.3 The 3 top-lines to highlight are:
 - Long term trends show that there has been an improvement in air quality but areas still remain above the annual mean air quality objective for Nitrogen Dioxide (NO₂);
 - Progress has been made on a number of actions in the Air Quality Action Plan and the report sets out the 2018 highlights; and
 - The Greater Manchester Clean Air Plan is projected to have the most significant impact on air quality in the city-region going forward.
- 1.4 Also within the submission are two datasets which cover information tables and historical diffusion tube data (2011-2018). These are at Appendix 2 and Appendix 3. A significant part of the ASR is the District reporting.
- 1.5 Greater Manchester's response to the 2017 DEFRA appraisal can be seen at 2.2.1 of the report.
