## **Details of Operational Decision Taken** [with reasons]:

Following a decision by Commissioning Board on  $27^{th}$  March 2019 to commission a Rough Sleepers Provision, an open tender exercise was conducted on the North West Procurement Portal (The Chest) under Public Contract Regulations to which bids were received on  $10^{th}$  May 2019.

The tender was not awarded due to the necessary funding not being agreed by GMCA.

An exemption under Contracts Procedure Rule 3 was agreed on 13/9/2019, commissioners approached an existing contracted provider who confirmed they were in a position to deliver the contract.
