Details of Operational Decision Taken [with reasons]:

The current contracts for Short Breaks for Children with Disabilities have been in place since 1st April 2016 and are due to expire on 31st March 2020.

To enable the analysis of need and for the new service specification to be co-designed and developed with children and young people and parents/carers the current contracts will need to be extended for the joint commissioning process to take place in a timely way.

The current contracts will continue to be to monitored and reviewed during the extension period to ensure they continue to meet the needs of children and young people with disabilities in Bury.

The recommendation is for a 6 month extension from 1st April 2020 to 30th September 2020 to be approved with the forecasted value as below:
