# STATEMENT OF COUNCIL'S JUSTIFICATION

# TM2/20/465 — DUNDEE LANE/CARR STREET/TANNERS STREET AND CALLENDER STREET, RAMSBOTTOM

Concerns have been raised regarding increasing traffic, particularly Heavy Goods Vehicles (HGV's) using Dundee Lane and The Rake, Ramsbottom as a cut through from the A676 Bolton Street/Bolton Road West to Helmshore Road/Lumb Carr Road.

At present there is a 3.5 tonnes weight limit restriction (except for access) on The Rake and Chapel Lane and there are a number of advanced 3.5 tonnes weight limit ahead signs located at the junction of Bolton Street/Bridge Street/Ramsbottom Lane and Carr Street.

In spite of the existing 3.5 tonnes weight limit, local residents believe that there has been an increase in the volume of HGV's and this has prompted then to call for further action.

There is a general concern among residents towards their safety when walking along narrow streets such as The Rake and Chapel Lane. In addition, properties are also affected by the vibrations caused by HGV's.

This was discussed by the Traffic Management Unit at its meeting of 03 December 2019, the decision being to recommend the introduction of a 3.5 tonnes weight limit (except for access) restriction to improve the Environmental Impact of Heavy Goods Vehicle traffic between Bolton Road West and Lumb Carr Road/Helmshore Road.

The extent of the proposed restrictions are described in the accompanying schedule.
