

Details of Operational Decision Taken [with reasons]:				
<p>To approve for advertising the proposals to introduce 2 new 'pop-up' Toucan crossings on the A56 Bury new Road near Sedgley Park Road & St Marys Road respectively. Additionally, approval is sought for a possible additional 'pop-up' Puffin crossing on the A56 Bury New Road south of the junction of Park View Road. No Traffic Management Unit minutes provided due to the timescales and fast track nature of this initiative.</p> <p>The locations of the proposed Toucan crossings are at Sedgley Park Road (to replace an existing refuge) and to the south of St Marys Road. Additionally, if funding can accommodate, an additional Puffin crossing is proposed to be introduced just to the south of Park View Road where a School Crossing Patrol currently operates. The initiative is part of the Greater Manchester Emergency Active Travel Fund (Tranche 1) submission to create temporary, 'Pop-up' crossings on the A56 between St Marys Road and the Salford border to enhance pedestrian and cycling facilities on this route. It is hoped that these crossings will become permanent features.</p>
