Details of Operational Decision Taken [with reasons]:

Due to a recent cabinet report submitted at November's Cabinet meeting on the 24th November 2020, a proposal, as part of a wider report, included the option to close the civic venue service.

At this stage, no decision to close the Civic Halls has been made, the civic venue team propose that they begin a public and stakeholder consultation at the beginning of January.

This will ensure that all engagement with stakeholders is positive and within the longest possible time period to allow for cancellation or moving the bookings to alternative venues.

As part of the consultation, a compiled questionnaire will identify and assess alternative venues, alternative wellness activities and potential alternative events to fulfil the role of the service.

Included as part of the public and stakeholder consultation, the civic venue team will consult with current long term bookings to organise alternative venues and/or to assist with cancellation to minimise the upheaval and reduce negative feedback.

Where appropriate, if bookings are required to move, they will remain in councilowned and operated venues including leisure centres, libraries and Adult Learning.
