Background

The Highways Investment Strategy – Tranche 2 was approved at Cabinet (item 119) on 29 July 2020 and aims to invest £10M in highway maintenance to improve the condition of the highway network.

The implementation and access to use the Greater Manchester Highways Alliance Framework to procure Civil Engineering works was approved at cabinet (item 120) on 29 July 2020.

The Final evaluation and the selection of preferred bidders under the Greater Manchester Highways Alliance Framework was approved under Delegated powers 297 dated 15 October 2021.

The above arrangements have been made to ensure the council is able to maximise the opportunity for securing best value. The approach promotes the principles of strong financial governance and is fully supported.
