1.1 The Licensing Act 2003 and the Licensing Act 2003 (Hearings) Regulations is the relevant legislation.

1.2 The Panel will make a decision on the day of the hearing and the parties will be notified subsequently of the decision and the reasons for it by letter from the Licensing Office.

#### 2.0 INTRODUCTION

- 2.1 The applicant for the licence in respect of the above premises is Cosalea Limited, 3 Coleridge Road, Greenmount, Bury, BL8 4EW. The proposed Designated Premises Supervisor (DPS) is Lisa Moore, 2 Crompton Fold, Bury, BL8 1RE.
- 2.2 The applicant has complied with all the necessary procedural requirements laid down by the Act.
- 2.3 As part of the statutory process the Responsible Authorities and interested parties are entitled to make representations in relation to the grant of a licence. Where representations are made and not withdrawn Members are required to determine them.
- 2.4 Representations must be relevant to the licensing objectives defined within the Act. The objectives are:-
  - the prevention of crime and disorder
  - public safety
  - prevention of public nuisance and
  - protection of children from harm

#### 3.0 THE APPLICATION

3.1 The application is for the grant of a Premises Licence under Part 3 of the Licensing Act 2003:

#### 6.0 OBSERVATIONS

6.1 After hearing the representations made and the evidence presented, Members are obliged to determine the application with a view to promoting the licensing objectives and having regard to the Authority's Licensing Policy and National Guidance.

#### Appendix One

- The premises are to operate an effective CCTV system which is to be maintained in good working order at all times the premises is open for business. The recording medium (e.g. disks / tapes / hard drive, etc.) and associated images are to be retained and securely stored for a minimum period of 30 days and are to be made available to the police / authorised officers of the Licensing Authority upon request. The premises licence holder or designated premises supervisor is to provide the police with the contact details of members of staff (or other person(s)) who are trained and familiar with the operation of the equipment so that, at the expense of the premises licence holder, they are able to check that the equipment is operating properly and that they are able to provide copies of recorded data upon request and within no more than 12 hours from the time of the request. The premises licence holder or the Designated Premises Supervisor must notify the licensing office or the Police in the event of CCTV breakdown as soon as is reasonably practicable and in any event within 24 hours.
- Staff training shall take place on the Licensing Act and Licensing objectives upon commencement of employment and every six months thereafter, a written record of this training is to be maintained and made available to the police and any authorised officer of the Council for inspection on request.
- A personal licence holder must be contactable when the premise is open to the public.
- Any Door staff employed at the premises must be SIA registered and a log must be maintained at the premises showing the full name, date of birth, contact telephone number and SIA badge number of the Door Security Staff on duty, the time when they started and ended their shift and the details of any incidents that take place to include incidents when a member of the public is refused entry to the premises. The log is to be made available to the police, to SIA inspectors and to Authorised Officers of the Licensing Authority on request.
- Any Door security staff employed to use their best endeavours to prevent persons loitering outside the premises.
- No person in possession of a drink in a sealed or unsealed container shall be allowed to enter the premises except for the purposes of delivery or from moving from one part of the premises to another.
- The premises are to maintain an incident book to record the details of incidents / crime / descriptions of individuals involved. The incident book must be made available to the Police/authorised officers of the Licensing Authority on request.
- Customers are to be prevented from leaving the premises with glasses or open bottles.
- No drink shall be removed from the premises in an unsealed container save for consumption in any delineated area.

- Clientele must not be admitted to the premises within 30 minutes of the end of licensable activity.
- The DPS/ Licence holder must ensure members of staff are adequately trained with regard to First Aid.
- There shall be maintained on the premises at all times an adequate and appropriate supply of first aid equipment and materials.
- The DPS or premises licence holder must develop and operate a dispersal Policy for clientele leaving the premises this may include links to taxis and other transport providers.
- Prominent clear and legible notices must be displayed at all exits requesting that customers respect the needs of local residents and to leave the premises and area quietly.
- Music and associated other noise sources (e.g. DJs and amplified voices) shall not be generally audible inside noise sensitive property at any time. The DPS or a member of staff is to carry out noise level checks of the surrounding outside area whenever entertainment is being provided taking action to reduce noise levels where there is a potential for nuisance to be caused.
- All external doors and windows are to be kept closed when live entertainment or recorded music is in progress.
- On occasions when the premises are used/hired to hold a 18<sup>th</sup>/21<sup>st</sup> Birthday party, At least one SIA registered security staff is to be employed at the premises for the duration of the function.
- On such occasions, the sale of alcohol and the provision of regulated entertainment is to cease no later than 23.00hrs.
- No refuse shall be disposed of or collected from the premises between the hours of 20.00 and 0800 where such disposal or collection is likely to cause disturbance to local residents.
- The premises will operate a "Challenge 25" proof of age policy, and signage to this effect is to be prominently displayed within the premises. Persons who appear to be under the age of 25 must produce for thorough scrutiny by staff, proof of identity/age before being sold/supplied alcohol. Only a passport or photo-card driving licence or a proof of age card bearing the official 'PASS' accreditation hologram should be accepted as proof of age.
- Whenever a member of staff refuses to sell alcohol to a person suspected of being under the age of 18, A record of the circumstances of the incident must be made. The refusals book must be made available to the police / authorised officers of the Licensing Authority on request.
- All alcohol must be displayed/stored behind the counter.
- No person under the age of 18 shall be permitted to remain on the premises after 22.00 hours except when present with a responsible adult.

Appendix Two

#### **Representation 1**

Dear Sirs, I wish to strongly object to the change of use and proposed hours of use at the above mentioned property.

These premises are less than 20 yards away from a number of residential properties and is therefore, I feel, totally unsuited to the holding of entertainment including live music, singing, live performers and playing of recorded sound up to as late as 0100 hours.

The noise will be easily heard from the bedrooms in the properties opposite as well as noise from people exiting the premises and traffic including idling taxis to pick up passengers. This will undoubtedly cause significant sleep disturbances. Not only that, but there will be considerable light pollution from the premises frontage which will again, cause sleep deprivation in the surrounding properties.

I am writing to object to the above premises opening every day until 11.30 pm and 1am on public holidays and days prior to bank holidays. I also object to them holding live music events, singing and the consumption of alcohol.

I live on Walshaw Road almost opposite Cosalea and this is a busy main road with lots of traffic. This is a residential area with a lot of elderly people who do not want to be subjected to the noise and the general nuisance behavior which will no doubt occur. Music and drinking lead to brawling and shouting. Car doors slamming and engines running late at night are unacceptable for residents. There is already problems with parking during the day with all the classes that are being run at Cosalea. Elton High school up the road generates lots of traffic and it's just a matter of time before there will be a nasty accident.

I find it unbelievable that the licensing department could even consider these extended opening hours along with the live music and alcohol.

I will also be seeking help from the Local MP about this matter and also ask them to intervene and assist quashing this application.

My mother lives at 2 Chiltern Drive, directly opposite Cosalea in a residential area populated by bungalows and lots of retired people. I need to stress this is a residential area and customers to both Cosalea and Body Influence Gym regularly forget this by continuing to impeding driveways/properties access on Walshaw Road, making excessive noise and an increase in litter within neighbouring gardens. This contempt and lack of respect will only be made worse by the influence and sale of alcohol at Cosalea.

The local residents are already submitting noise recording to the Environmental Health Department as gym classes run throughout the day till 9-10pm at night. This will only be exacerbated by allowing Cosalea to pay loud music and sell alcohol.

My mother is at breaking point! Her health and wellbeing is deteriorating by these businesses and she feels forced out of her home. Please consider my mother and her neighbours by rejecting this application.

We have lived here for over 20 years and as retired people we do not think that we should have these problems with excessive noise that the above would cause both from the music and parking issues.

#### **Representation 7**

I am deeply aggrieved and I understand that planning permission for extended hours has already been granted to this Café. Its surprising how none of the residents who rejected to a similar proposal last year received any notification by letter considering the owners stated that they were posted to local residents. This is very underhanded and a deliberate used method not inform residents on their doorstep, who if you grant this application will be subject to no life as we know it now. I am already sending twice daily noise level reports of Body influence fitness Centre to Bury government environment department where the owner plays loud music and shouts instructions over the music to members throughout the day. Is it your intention to force existing residents to vacate their properties they have lived in for some considerable time to honor a new establishment giving them the right to disrupt our lives further? This is a residential area populated by bungalows where residents are mostly retired where is their need to have a music venue on their doorstep playing loud music, hosting bands and serving alcohol till late at night and the early hours of a bank holiday weekend?
