1.0 BACKGROUND

1.1 The report advises Members on operational issues within the Licensing service.

2.0 LICENSING HEARINGS SUB COMMITTEE - 10th August 2021

2.1 A hearing for an application of a Grant of a Premises Licence in respect of Mozzarella, 5 Kings Road, Prestwich, M25 0EU to which two representations were received from Councillors. The Sub-Committee considered the report and heard the representations. Members resolved to grant the application with the amended hours and additional conditions that had been proposed and agreed with Greater Manchester Police.

2.2 A hearing for an application of a Grant of a Premises Licence in respect of Cosalea, Walshaw Park House, Walshaw Road, Bury, BL8 1PY to which representations were received from interested parties. The Sub-Committee considered the report and heard the representations. Members resolved to grant the licence subject to the agreed conditions from Greater Manchester Police.

3.0 COVID MARSHALS

3.1 One covid marshal has now commenced in post and is on a fixed term contract until August 2022. We are still awaiting a start date for the other candidates.

4.0 PARKLIFE

4.1 The annual Parklife festival at Heaton Park is due to take place on Saturday 11th and Sunday 12th September with New Order on Friday 10th. Officers will be working throughout and will be joined by the Covid marshals. Letters have been delivered to residents of Sheepfoot Lane, Meade Hill Road and Middleton Road to advise of the requirements for a Street Trading Licence should they be thinking of selling any goods from their properties. Licensed premises in the area will be visited prior to the event.

5.0 COMPLIANCE VISITS

- 5.1 Officers from the Public Protection Service have undertaken evening visits on the 20th August 2021 to licensed premises throughout the borough. Twelve visits were carried out as a result of complaints received. One new premises was visited to advise on the requirement for a licence and general compliance visits were carried out in Bury town centre.
