STATEMENT OF COUNCIL'S JUSTIFICATION

TM2/20/474:- Irwell Street/Palatine Street, Ramsbottom

Concerns have recently been raised by a local Councillor regarding parking concerns on Irwell Street, Ramsbottom.

Irwell Street provides access to the Morrisons overflow car park, the service yards of both Tesco and Morrisons and Ramsbottom Metalwork. Large parts of Irwell Street are protected by either single or double yellow line traffic regulation orders.

There is a section of unrestricted parking on the north side of Irwell Street on the immediate approach to the Tesco Service Yard Access. Parking that takes place in this location combined with the narrowness of the street can cause difficulties for HGVs negotiating the street and accessing the service yards with the potential for over running the footway on the opposite side. As such it is suggested that the introduction of double yellow lines is appropriate in this location.

It has become apparent that the markings on site do not reflect the current traffic regulation orders. On site double yellow lines are in place for the full length of the south side of Irwell Street. On the north side of Irwell Street double yellow lines are in place from the cul-de-sac end to the west side of the Tesco Service yard access, and there is 15 metres of junction protection on the north side at the Railway Street junction.

In addition to the introduction of double yellow lines on the unrestricted section, it is proposed that the existing traffic regulation orders be rationalised to reflect the markings on site.

Due to the width of Palatine Street parking can only be accommodated on one side of the road. As such it is intended to formalise this arrangement with the introduction of No Waiting at Any time restrictions on the west side of Palatine Street between Irwell Street and King Street.

This was discussed by the Traffic Management Unit at its meeting of 28 January 2020, the decision being to recommend the revocation of the No Waiting Mon-Fri 8am-6pm, Mon-Sat 8am-12.30pm introduction of No Waiting at Any time restrictions on Irwell Street, and the introduction of No Waiting at Any time restrictions on Palatine Street, Ramsbottom, in order to facilitate traffic movements and access.

The extent of the proposed restrictions are described in the accompanying schedule.

SCHEDULE

<u>Introduction of No Waiting at Any time and Revocation of Existing Extents of</u> <u>No Waiting Mon – Fri 8am-6pm, Sat 8am – 12.30pm</u>

Palatine St, Ramsbottom – West side, between Irwell St and King St AND East side, from the southerly kerbline of King St for a distance of 5m in a southerly direction AND East side, from the northerly kerbline of Irwell St for a distance of 10m in a northerly direction

King St, Ramsbottom – south side, from the westerly kerbline of Palatine St for a distance of 5m in a westerly direction


Irwell St, Ramsbottom – both sides from the westerly kerbline of Railway St in a westerly direction up to an including the cul-de-sac end

Retention of No Loading 6am – 6pm Sat, Sun & Bank Holidays

Irwell St, Ramsbottom – north side from the westerly kerbline of Railway St for a distance of 15m in a westerly direction AND

South side from the westerly kerbline of Railway St for a distance of 53m in a westerly direction

Irwell Street, Ramsbottom Restrictions as per Existing TROs







Irwell Street, Ramsbottom Proposed Restrictions Plan




