- 3) Via Back Silver Street & Parks Yard & vice versa

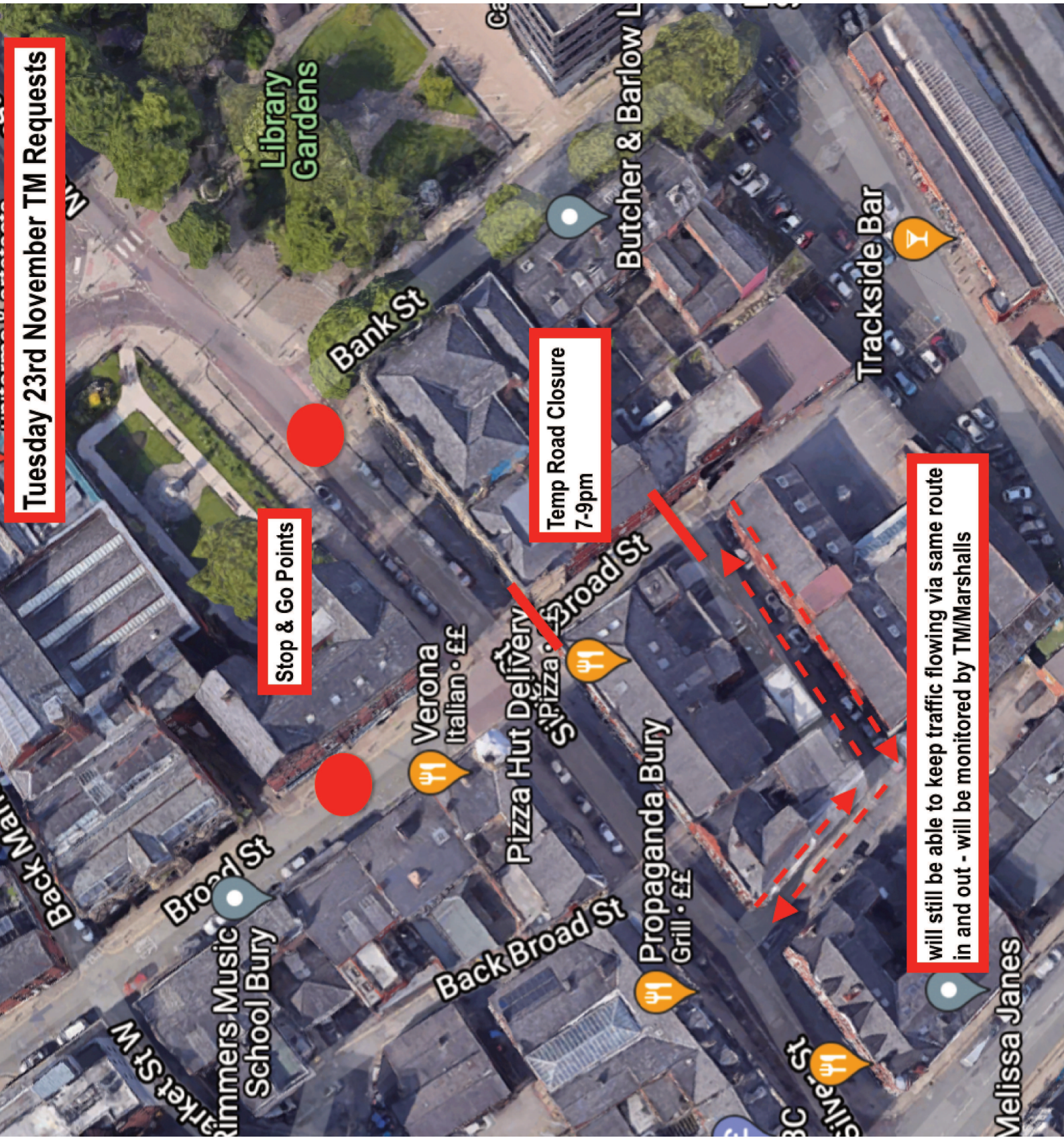
The notice will come into operation on Monday 22/11/21 and last for a maximum of 5 days only (anticipated duration 2 days maximum).

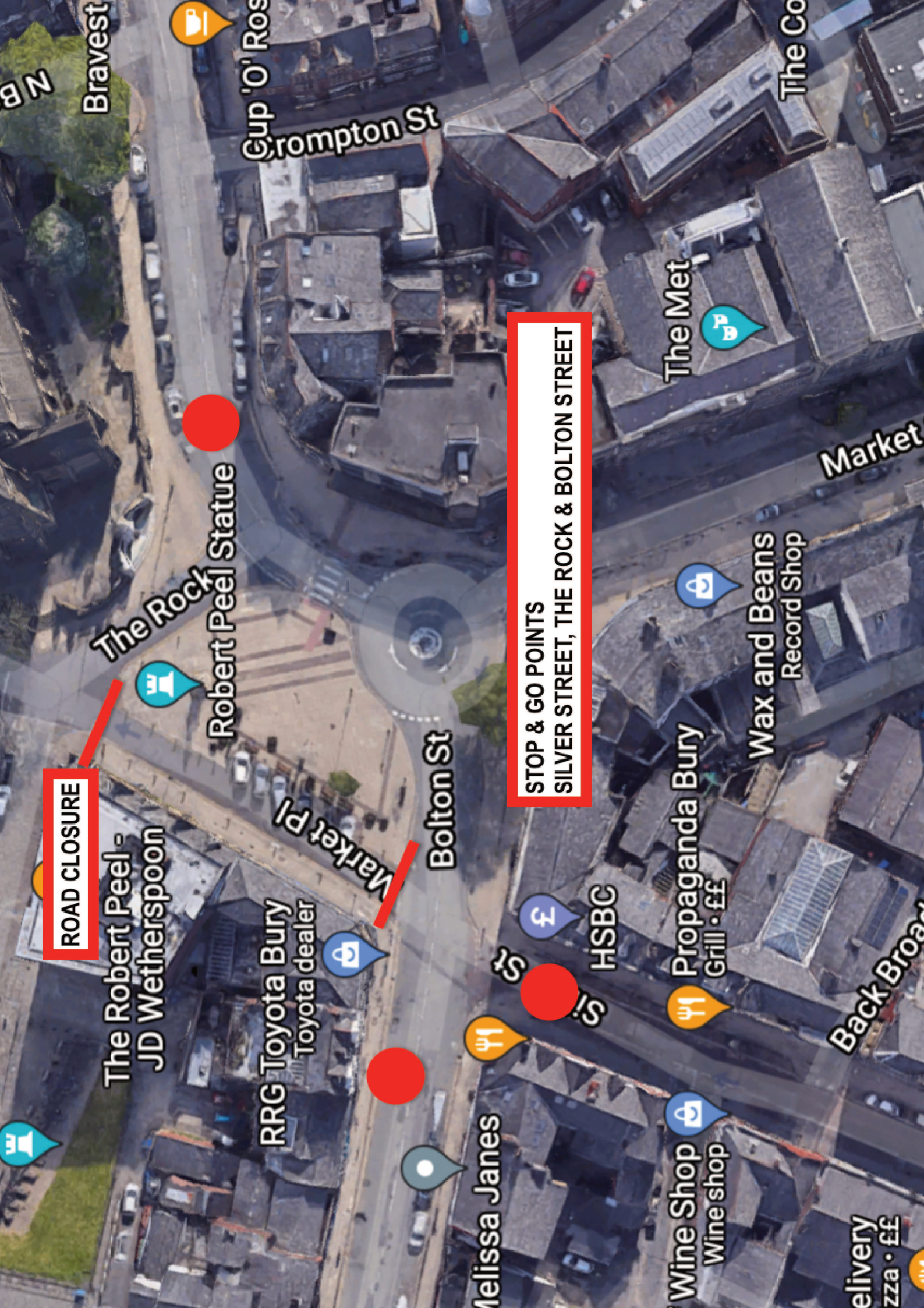
