1. INTRODUCTION

- 1.1 A paper was brought to the previous meeting of the GM Population Health Board on 8/10/21 setting out proposed terms of reference for a refreshed and strengthened GM Population Health Board.
- 1.2The draft terms of reference were largely supported, subject to some amendments relating to:
 - The oversight role of the group in relation to the Population Health ambitions in the GM Strategy, rather than a leadership role.
 - The importance of group members linking back into the groups whom they are representing.
 - Incorporating potential EPPR responsibilities if that becomes a future requirement.
 - Including reference to the establishment of short-term task and finish groups to progress specific actions.
- 1.3 These changes have now been made and the proposed final Terms of Reference for the refreshed Population Health Board are attached as **Appendix 1**.

Terms of Reference (Final)

Purpose:	To provide collective whole system leadership and accountability for developing, implementing, and overseeing a whole system approach to population health in Greater Manchester, with a primary focus on improving health outcomes, reducing health inequalities, and providing oversight of the GM ICS Population Health functions.
Key Roles & Responsibilities	Leading the ongoing development of GM as a Population Health System.
	Leading the implementation of the recommendations of the Build Back Fairer review of health inequalities in Greater Manchester.
	 Ensuring that the voices and insights of local people are heard, considered, and applied.
	Overseeing the implementation of the GM Population Health System Characteristics Framework.
	 Ensuring that long term, sustainable investment is a feature of the GM Population Health system and that resources are used in a manner that achieves the desired outcomes and provides value for money.
	Collectively shaping city-regional policy and strategy to ensure it is conducive to achieving good health.
	Oversee the implementation of the population health ambitions set out in the refreshed GM Strategy .
	 Collectively influencing national policy and strategy to enable a positive impact on GM citizens.
	 Interpreting and responding to strategic population health intelligence and monitoring key health and wellbeing outcomes (including the Marmot Beacon Indicators), identifying areas of poor performance and agreeing remedial action, and identifying strong performance and opportunities to share best practice.
	 Providing oversight to the delivery of the GM ICS Population Health functional responsibilities, including those which relate to health protection.
	 Overseeing the statutory Public Health responsibilities of the GM ICS, including the commissioning of nationally mandated Screening & Immunisation and Health & Justice programmes.
