1 Background

- Bury Council has received funding via AEB (Adult Education Budget) to deliver local Digital Inclusion projects. - 1.3 In their capacity as a commissioned service for Bury Council, Bury Blind Society were included in the discussions to see how this pilot would impact on the rehabilitation service already offered by the Council via Bury Blind Society.
- 1.4 Although there would be no financial benefit to Bury Blind Society to work on this programme, the proposal was recognised as an opportunity to enhance the digital assessment undertaken during the initial home assessment by the Early Intervention Team.
- **1.5** Bury Blind Society have agreed:
 - To identify people who would benefit from the programme.
 - Use of their premises for Henshaw's to deliver clinics.
 - Co-ordinate access to the programme.
- There is a financial implication to the Charity's participation on the project regarding use of premises with increased utility costs, together with volunteer driving expenses bringing clients to the clinics.
- 1.7 There is not enough money in the grant to allow Henshaw's to contribute towards the premises costs.
- The grant will not cover travelling expenses. However, there will be a small number of clients who will wish to access this service but are unable to attend the clinic without assistance. Use of public transport / private taxi is not an option to some of Bury Blind Society's clients due to needing someone to sight-guide them.

2 Financial Implication

Bury Blind Society estimates the financial implication to support the 12-month pilot is £2,028.00.

£80 per day x 2 per month = £160.00 per month

Volunteer expenses: based on one client per clinic 10-mile round trip at .45p per mile $£4.50 \times 2$ per month = £9.00 per month.

3 Conclusion

- **3.1** Digital inclusion is about making the opportunities of the internet and digital technology available to everyone, tackling inequalities and improving outcomes.
- This pilot will help to improve accessibility and digital inclusion for the blind and low-vision community, who are often a group closed off from the internet and digital technology which can be a crucial resource for all aspects of life.

4 Recommendation

The recommendation is to invest £2,000 for 12-months, as a contribution towards the premises costs and volunteer travelling expenses costs Bury Blind Society will incur to support adults with visual impairment the opportunity to participate in a digital enablement pilot.
