Summary: To award Works Package AMHS2-01 (2023/24, estimated cost \pm 312,000) and Works Package AMHS2-02 (2024/25, estimated cost \pm 320,270) under the Greater Manchester Highways Alliance Framework to:

<u>LOT3 Works – Carriageway Surfacing</u> J Hopkins Ltd, Monde Trading Estate Westinghouse Road Trafford Park M17 1LP

<u>LOT4 Works – Road Markings</u> W J North Limited, 7 Brock Way Knutton Newcastle-under-Lyme Staffs ST5 6AZ

Options considered: The Contractors selected are the preferred bidders from the procured Greater Manchester Highways Alliance Framework.

<u>Background</u>

Bury is to receive $\pm 323k$ for 2023/24 and $\pm 323k$ for 2024/25 from reallocated HS2 funding, (Network North).

Approval is sought from the Cabinet Member for Environment, Climate Change and Operations to use this budget to resurface:

Church Street and Booth Street (Church Street to Rhode Street) Walshaw estimated cost £312,000 from the 2023/24 allocation,

and

Bank Street, Walshaw and Croft Lane, Hollins, Whitefield estimated cost $\pm 320,270$ from the 2024/25 allocation.

The implementation and access to use the Greater Manchester Highways Alliance Framework to procure Civil Engineering works was approved at cabinet (item 120) on 29 July 2020.

The Final evaluation and the selection of preferred bidders under the Greater Manchester Highways Alliance Framework was approved under Delegated powers 297 dated 15 October 2021.

The above arrangements have been made to ensure the council is able to maximise the opportunity for securing best value. The approach promotes the principles of strong financial governance and is fully supported.

<u>Decision</u>

It is recommended that Works Packages AMHS2-01 and AMHS2-02 be awarded to Bury Council's preferred bidders, from Greater Manchester Highways Alliance Framework, at an Estimated Works Cost of £312,000 and £320,270 respectively.
